### 3.3 Other planning matters (discussion only – no decisions)

Cllr March reported that at the Land near to Bassett's Farm, Maidstone Road, the appeal had been dismissed. The works had been considered to be major excavation works, so it is possible that enforcement may insist on the land being reinstated to its original condition.

Cllr March also reported that TWBC had now looked at the five options set out for the new Local Plan and were carrying out feasibility studies for each option and considering their development in more depth.

Gypsy and Traveller sites were also being considered by TWBC and it was thought that capacity could be fulfilled by increasing the size of existing sites slightly rather than creating any new sites at present.
