Minutes of a Planning Committee Meeting held in the Parish Council Office, Langton Green Recreation Ground, on Monday 10<sup>th</sup> November 2014 at 7.30pm

**MEMBERS OF THE PUBLIC PRESENT:** There were two members of the public present.

- **1.** To enquire if anyone present intends to film, photograph and/or record the meeting: No-one present intended to film, photograph and/or record the meeting.
- 2. Apologies and reason for absence: Cllr Barrington-Johnson (prior engagement)

They said that they are the applicants and that the downstairs wet room is necessary for health reasons. They said that the proposal is the minimum size necessary and a sympathetic design and the two immediate neighbours are supportive. They also said that the extension is designed in such a way that it would be easy to remove in the future if required.

It was agreed to bring these applications forward on the agenda.

Location: Saxons, St Mary's Lane, Speldhurst, Royal Tunbridge Wells Proposal: Demolition of 2 storey existing house and 1.5 storey outbuilding and construction of new 2 storey house and outbuilding

Decision: Remain neutral – leave to Planning Officer Comment: If TWBC is minded to grant planning consent we would ask that there is a non-severance condition in respect of the outbuilding

Location: Langton Green Primary School, Lampington Row, Langton Green, Royal Tunbridge Wells Proposal: Details of a biodiversity enhancement strategy pursuant to condition (11) and a revised school travel plan pursuant to condition (12) of planning permission TW/14/154

# Decision: Remain neutral - leave to Planning Officer

Comment: Concern is expressed that Speldhurst Parish Council have not been consulted on the Travel Plan and consider it to be totally inadequate and in breach of the planning consent condition 12: 'Within 6 months of the date of this decision, a revised School Travel Plan, with initiatives to be developed in liaison with representatives from Speldhurst Parish Council, shall be submitted to and approved in writing by the County Planning Authority, and thereafter be implemented as approved and subject to ongoing monitoring and review.'
