### **NOTIFICATION OF ESSENTIAL MAINTENANCE WORKS – A5 KILSBY TO WEEDON**

I am writing to let you know that we will be carrying out essential maintenance work on the A5, between the A45 Weedon crossroads and Kilsby.

During this comprehensive scheme of work, we will repair damaged drains, resurface the carriageway, renew bridge joints and kerbs, refresh road markings and install road studs and traffic loops.

Once completed, all road users will benefit from improved road safety and a smoother carriageway.

#### **When will the work take place?**

Work is due to start on **4<sup>th</sup> March 2019** and is scheduled for completion by the **end of October 2019**.

To keep our programme for these works as short as possible and to minimise disruption to the local community, residents, business and road users, we will work:

- between 8pm and 6am, Monday to Thursday (week night closures)
- from 8pm Friday until 6am Monday (full weekend closures on selected weekends)

Please note that all our planned roadworks may be subject to change due to weather conditions or unforeseen circumstances.

#### **How will the work affect traffic?**

To maintain a safe environment for our workforce and customers, the A5 will be closed to through traffic between the A45 Weedon crossroads and Kilsby during our working hours.

Please refer to the attached drawing for further detailed information.

During these closures we will put in place fully signed diversion routes which have been agreed with the Local Authority.

#### **How will the work affect businesses and residents?**

We will make sure that access to businesses and residences is maintained wherever possible.

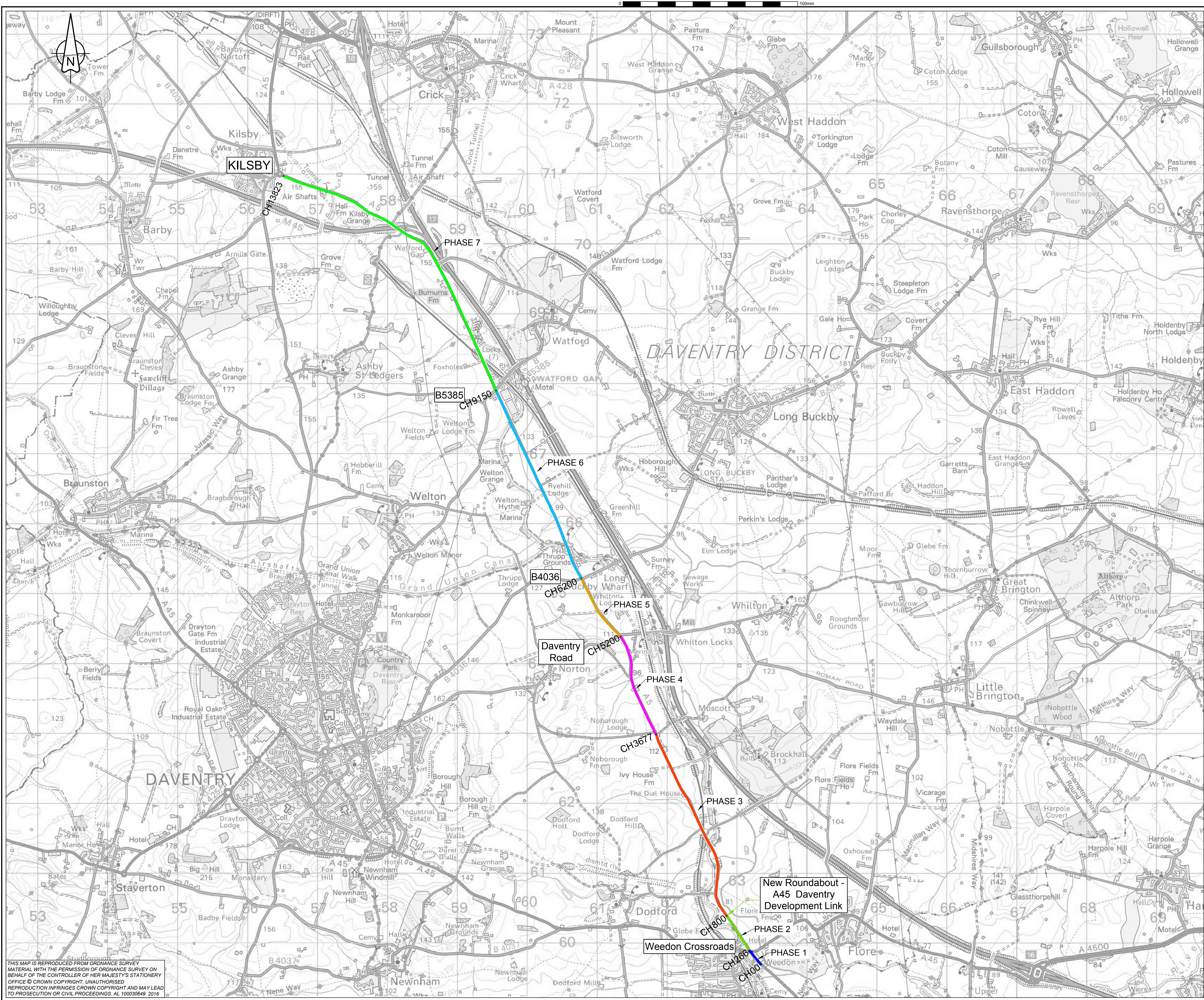
