- 4. Matters arising:

Woodland adjoining Church Road, Woolton Hill. Cllr. Titcomb updated the meeting on the current situation.

Cllr. Titcomb has contacted Frank Wright the Tree Officer at BDBC. He was not aware that the trees were subject to TPOs but documents which suggest this is the case have been shared with him. His response is awaited.

Regarding the public safety aspect, which is the most pressing issue, he referred Cllr. Titcomb to HCC. There is no way of speaking with them directly but an email has been sent raising the matter as an urgent one and confirming that liaison with the Tree officer is required because of the TPOs. Cllr. Titcomb will keep the committee updated.

5. **T/00171/20/TPO - 8 Greenlands, Woolton Hill, RG20 9TB.** Oak Tree: reduce crown.

Decision left to the expertise of the Tree Officer.

6. **20/01169/HSE - 3 Falcon Coppice, Woolton Hill, RG20 9UE**. Erection of a single storey side extension and new pitched roof over existing.

No comments or objections.

7. **A.O.B**:

a) 20/01092/HSE – The Beehive, Hollington Lane, Woolton Hill, RG20 9XT. Erection of a garden store lean to building.

Cllr. Watson recused himself from discussion of matter as he knows the applicant well.

This application was received since the publication of the Agenda for this meeting. As response date is the 16<sup>th</sup> June and our next scheduled meeting is the 29<sup>th</sup> June, a long extension would be required to respond in time. Cllr. Cooper felt that a long extension on what appears to be a very straightforward application would be unlikely to be granted.
