- 2. Casual Vacancy**

A casual vacancy had occurred with the resignation of Tom Webb. SBDC had been informed and we are waiting to hear if there have been any applicants for the post. Cut of time is the 18th July. Should there be no applicants, then the Chairman will then consider co-option.

- AC told Councillors that she had spoken to the Police regarding information which had been passed to several local residents about the incidence of drugs dealing, specifically near the bus stop.**
- AC had also attended the Crime Panel meeting. Even though burglary was down, the concern was the rise in doorstep selling and intimidation techniques for unnecessary and overpriced household maintenance.**
- AC also mentioned that the rumours regarding Wexham Park Hospital are completely unfounded.**

- 5. County Council Matters**

Councillors are still very concerned about the state of the potholes in Hedgerley; nothing seems to have been done at all.

- **Mobile library**
Following the information at the last meeting regarding the Rotarians setting up a lending library, there is the possibility of a similar arrangement being organised in Hedgerley, with the hope of using the Youth Club for this purpose. JE will follow this up.

- **Bedford Cottage, residents' concerns**
Clerk had been contacted by several residents who were very worried about the planning applications which had been presented for Bedford Cottage. Several residents attended the PC meeting and voiced their concerns, not only about the increases in the original plans, but by the now moving of the whole site further back, which would result in the surrounding properties being affected. DB confirmed that HPC would be giving their objections to the plans.

- **Clerk has received delivery. MER said that since the metal bench nearest the shops had broken and been removed, it would seem a better idea to put one of the new benches in its place. Councillors agreed.**
The benches will be installed next week (w/e 25th July) and Councillors agreed it would be a good idea to have some sort of ceremony to mark the WWI bench.

- **Two quotes had been received; one for using concrete formed posts, and the other for timber. Councillors preferred the idea of timber and wanted the Clerk to confirm with the contractor what wood he would be using.**
