# MINUTES OF THE DEWLISH PARISH COUNCIL MEETING HELD ON MONDAY 27<sup>™</sup> FEBRUARY 2023 AT DEWLISH VILLAGE HALL COMMENCING 7.30PM

A presentation was given by Ian Colley and Chris Tattersall of Wessex Water explaining the effects of water abstraction from the Devil's Brook. A copy of the presentation is available on the Parish Council website.

# **Public Participation**

Pound Lane BOAT – a meeting is due to be held on Tuesday7th March for all residents.

Village News – A question was raised as to why Dewlish were not submitting entries each month. The Clerk confirmed that a report is sent in each month. However, as the Parish Council do not meet in December, no report would have been sent for that month and it may be that this is what has caused the confusion. The Chair will follow this up.

20mph initiative – Mr Church reported that he had been looking into the Dorset Council proposal. He confirmed that there was now no longer a need for a public consultation to prove the support of the residents. However, there may be a cost of approximately £10,000 involved which would have to be covered by the Parish Council. Cllr Haynes reported that it was not possible to reduce a speed limit from 60mph to 20mph. It would be necessary to get the existing limit reduced to 30mph before looking at any further reduction. The Parish Council had undertaken traffic surveys in January in order to begin the process of gathering evidence. However, despite chasing, the results have still not been received from Dorset Highways.

### 1. To receive apologies for absence

22.157 Apologies had been received from Cllr Mike Fell.

Cllr Uden reported that Cllr Barbara Ross had stepped down from the Parish Council. Our thanks are extended to her for all her help during her time on the Council and we wish her well for the future. The Parish Council will now be looking to fill the vacancy by co-option at the March meeting.

### 2. Declaration of pecuniary and other interests

22.158 No interests were declared.

### 3 Minutes of previous meeting dated 23<sup>rd</sup> January 2023

22.159 A copy of the minutes had been issued to all members prior to the start of the meeting. Cllr Barnett proposed them to be a true and accurate representation of the meeting. This was seconded by Cllr Fisher and agreed unanimously. The Chair signed the minutes in the presence of the meeting.

#### 5. To receive the Dorset Councillor's report

22.161 Cllr Haynes' report continues to be received and issued each month. There will be a full meeting of the Dorset Council on the 28<sup>th</sup> February with the main topic being the question of charging double council tax on second homes. The Levelling Up Bill is likely to give local councils the ability to do this. However, if it does become law, those home owners affected will be give a year's notice before the charge can be put in place. There would then be a further year whilst all the necessary information was gathered and the charges issued. By agreeing the action now, it will mean everything will be in place should the Bill be confirmed. The additional charge will not apply to homes rented out as holiday lets.

#### 6. To receive reports on the following matters and to agree actions

## 22.162 Planning

P/HOU/2023/00429 Guinea Cottage, Pound Lane Erect rear extension

It was noted that the proposal covers an area of approximately 26.4sqm with a pitch roof and is to the rear of the site. It cannot be seen by any of the neighbours and the materials are in keeping with the surroundings. Cllr Uden proposed the application is supported. This was seconded by Cllr Barnett and agreed unanimously.

# 22.164 Parish Amenities and Rights of Way

- (a) To receive an update on the Shailes culvert work A 140m strip has been completely retarmacked and the level of the road raised in one section. This has resulted in a fairly steep drop on the south side along this section. Several residents have reported suffering punctures as a result of the original potholes prior to the work being undertaken. When reporting this to Dorset Council, they have simply been thanked for reporting the potholes and no recompense has been offered for the damage to their vehicles. Cllr Haynes offered to speak to Simon Gibson, Lead Member for Highways, and see if he would be available to attend the site and offer advice on how to move forward with any such claims. In addition, Cllr Uden has written to Highways to ask them to resolve the potential problem regarding the south side of the road where the increase in level may result in further issues. To date, no response has been received.
- (b) The Green update The tree work has now been carried out. Cllr Uden will be meeting a specialist play advisor on site on the 7<sup>th</sup> March and will report back to the March meeting.
- (c) Pound Lane A meeting will be held on Tuesday 7<sup>th</sup> March at 7.30pm in the Village Hall and will be open to all residents.
- (d) Volunteer Working Party Cllr Barnett reported that the high viz jackets have yet to arrive. A list of jobs will be drawn up.


