9 MINUTES OF THE MEETING HELD ON 9 APRIL 2018

53 It was proposed by Cllr Osborne, seconded by Cllr Sefer and agreed the minutes of the meeting held on 9th April 2018 be signed as a true record.

10 MATTERS ARISING

54 No matters were raised.

11 STANSTED SCHOOL**55 a Steering Group Update**

The Chairman suspended the meeting to allow Mr Sheldon to speak.

Mr Sheldon reported that the purchase completed on 24th April. Three schools had expressed interest. Sport England was still objecting to the planning application for change of use on the grounds of any car parking that would intrude into the sports field area would mean a loss of sports provision. The Steering Group was now considering extending the hall car park. There might have to be a fresh planning application and the cost would be £231. The front garden and playground had been mostly tidied up but there was a little left to do. He had been negotiating with KCC on a commuted sum to determine the lease on the playground site and £10,000 had been offered.

The Chairman thanked Mr Sheldon and reconvened the meeting.

Cllr Bott then proposed the commuted sum be accepted. This was seconded by Cllr Mrs Falconer and agreed.

12 **PLANNING**

a Applications

57 **i TM/18/00640/FL: Rose Cottage, North Down, Plaxdale Green Road, Stansted: Extension of outbuilding to form residential annexe for North Down.**

After discussion, it was agreed to object as follows:

Stansted Parish Council objects to this application. The proposal would create an additional dwelling in the Metropolitan Green Belt, which is contrary to planning policy. In addition, it is considered the raised roof would dominate the street scene. It is noted that permission for a similar dwelling with a lower roof line was granted, it is believed on appeal, in 2007. However this permission has long expired and should not be used as a precedent to grant permission.

Should the Local Planning Authority be minded to grant permission, the Parish Council requests that a condition is imposed that the new dwelling is ancillary to North Down and can only be occupied by the owner of North Down and not let out. Members would also ask that the roof line be lowered to prevent accommodation in the roof space as they consider a bedroom could well be incorporated within the current footprint on the ground floor. There are also concerns that the hedges and trees are preserved and that an additional entrance is not created.

Cllr Bott proposed that he and the Clerk meet to formulate a policy and that the matter be deferred to the next meeting.

Cllr Rayner said he had been a member of Kent County Council for a year, which had been interesting. He was a member of several committees. The County Council had moved many of its services to limited companies. He would continue to offer his assistance to the Parish Council.

Cllr Coffin said that the Local Plan would be out for consultation. S 106 money for affordable housing had been used to purchase properties for temporary housing. The recycling contract was out for tender and there had been a huge variation in prices. It was currently under evaluation. Cllr Betts said the M20 would be converted to a smart motorway between junctions 3 to 5.

The Chairman thanked the County and Borough Councillors and reconvened the meeting.
