6. Declaration of Interest.

7. Minutes of the previous Meeting.

The Minutes of the previous meeting were circulated to all present. These were proposed by Cllr Cathcart as a true record, this was seconded by Cllr Mace and agreed by all present.

The Minutes were then signed and dated by the Chairman of the meeting.

8. Matters Arising.

The Clerk was asked to contact MBC and ask them to sweep Pett Lane, Pett Road and South Green Lane.

10. Consultation on the Meeting Agenda.

a. Members of the Public.

A resident asked to speak under Highways Matters.

b. Parish Councillors.

11. Police Report.

The Police gave their apologies to the meeting.

Cllr Garten informed members that a new PCSO had been appointed for Stockbury. He stated that he would forward the details on to members.

Members asked the Clerk to forward the meeting dates onto him and invite him to attend a future meeting.

12. Highways Matters.

a. General Highways Matters.

Cllr Southern reported that the drains were blocked at the bottom of Chalky Road.

Action: Clerk to action.

A resident stated that Steps Hill Road was still closed and she asked what was happening and what the future was for the Road.

The Clerk was asked to contact KCC to find out what the issue was and if the road would be reopened.

A resident asked about the speed along the A249 as there had been a recent fatality, she asked whether the Parish Council could have any influence over this.

Cllr Cathcart reported that Helen Whateley was due to arrange a date for the A249 Action Group meeting and this would be a matter for discussion at this meeting.

Junction 5 Consultation- The Chairman stated that there had been no update since the Consultation. Cllr Cathcart stated that he would liaise with Highways England to ascertain the details.

Councillor Garten spoke regarding the A249 bus stop and stated that this appeared to have been put on hold.

b. Quiet Lanes Scheme.

Cllr Southern stated that KCC Officer Sue Laport had confirmed that the signs could be erected and KCC Councillor Shellina Prendergast had stated that she would finance these.

She suggested that when the signs were erected that a letter should be sent to local businesses to inform them of the signage.

c. Speeding in the Parish.

Cllr Woods circulated a paper to all members for consideration. He stated that this outlined his thoughts on speeding in the Parish.

He stated that the way people drive through the Parish was dangerous. He suggested that the PC could undertake an initiative to try to address the issue and seek residents support in taking action.

He asked if the PC wished to address the issue and undertake a project throughout the year and he asked members thoughts.

Cllr Cathcart stated that this matter could be raised with the PCSO.

Councillor Garten spoke regarding the possibility of the PC purchasing a speed camera. This was discussed by members and it was agreed that little could be done with the data that was collected from a speed camera.

Following a further discussion it was agreed that this matter would be out on hold for the time being.

13. Planning Matters.

a. Planning Applications.

Cherry Tree Farm

Cllr Woods stated that the Borough Council had put a Stop Order on the site and now an application had been submitted, he asked members views.

Councillor Garten stated that the Enforemcent Officer was surprised that an application had been submitted and he suggested that the PC object to the application.

Cllr Southern spoke regarding the objections she had received from members of the public on the grounds of AONB encroachment and creeping development.

Cllr Cathcart referred to the refusal notice for the Wheatsheaf and suggested that the reasons for this refusal also applied to the application for Cherry Tree Farm. It was therefore agreed that the PC should object to this application on the same grounds as the Wheatsheaf refusal.
