The rubbish on Rectory road has been cleared up by Cllr Brett and Cllr Mutimer has cleared the ditch between Keepers Cottage and the Rectory. Cllr Neld and her husband have cleared rubbish from Felmingham Road. All were thanked for their help.

Tyres have been dumped in the woods. Cllr Jack Almey will remove these.
