BASILDON PARISH COUNCIL

Minutes of the meeting of Basildon Parish Council held on the 13th March at the Village Hall in Upper Basildon.

OPEN FORUM

Mr Noble and Mr Goosey attended the meeting as trustees of Emery Down Wood and presented an update on the charities latest work. Last year saw important tree surgery carried out following various storms and 2024 is set to see a biodiversity survey carried out over three seasons to establish the types of animals living in the space along with details of the trees, wild flowers etc. The cost of this will be £3,367 including VAT and the results will be used to drive future projects and initiatives. The Trustees asked for the Parish Council to consider a grant to help with the cost; the Chairman confirmed that this will be discussed and the trustees informed.

MINUTES

The minutes of the meeting held on the 14th February having been circulated to members were declared correct and signed by the Chairman.

PLANNING

The Parish Council considered the following new applications:

24/00226 Knappswood Farm – two detached double garages (plots 1 and 2)

The Parish Council reviewed and voted to object on the following grounds:

The additional buildings are outside the settlement boundary and part of the proposal (gates) appear out of keeping with the rural area in which they'll reside.

The Council noted that previous applications for this site have contained garages (16/02407) which were removed as part of the scaling down of the site only to re-appear in this latest request.

Should West Berkshire Council approve the application, the Parish Council requests that a condition around lighting that meets dark skies requirements is added.

24/00382 Collabrack, Pangbourne Road – extension

The Parish Council reviewed the application and had no objections subject to the views of neighbours.

GENERAL ITEMS

The Council remains keen to support any initiative locally that supports a healthy and active lifestyle. The Clerk asked for permission to approach Beale Park to see if the Parkrun concept had been considered in a bid to introduce more visitors and engage more with the local community. The Parish Council fully supported this, including the potential financial backing of such a venture should Beale Park or another site beg found. The Clerk will kick off proceedings by contacting the relevant trustees.

The Chairman confirmed that following the sharing of quotes and an out of meeting vote by Councillors the grass cutting contract has been awarded to Tactical FM. The Clerk has written to the company to confirm the appointment.

The performance of the Clerk was discussed with the Chairman set to circulate various pay options to Councillors for discussion outside of the meeting.

Councillor Chadwyck-Healey updated the meeting on streetlighting. He will write to the Country Neighbour to outline the Councils plan to reduce operating hours during the period midnight to five am. A notice will be put on the website and at the relevant bus stop by Wakemans to advise those residents local to the lights of the proposal.

The clerk will follow up the potential website upgrade with Vision ICT and report back.

Councillor Greasley agreed to look into online banking for the Parish Council and will report back at either the April or May meeting.

The clerk requested declaration of interest forms be returned at the earliest convenience following a request from West Berkshire Council.

DISTRICT COUNCILLOR UPDATES

An accident was reported on the Hook End Lane crossroads, the third in a matter of months. The district councillor has driven the road section from Kiln Hill to the Crossroads and has shared her concerns with West Berkshire highways.

FOOTPATHS, HIGHWAYS AND OPEN SPACES

No issues were reported other than a number of muddy sections.
