### 2326/25) To receive the Chair's report

Good evening everyone,

I'd like to give you a brief update on what's been happening in our village over the past couple of months.

Back in July, Bassetlaw did an excellent job cutting the church grounds, with another recent cut.

I'd also like to thank Jamie Wright, who has been hard at work throughout the summer keeping the village neat and tidy—something I'm sure you've all noticed and appreciate.

Work has continued on tackling issues such as anti-social behaviour and other associated problems, with Hollie and her team making real progress in restoring order in Crookford and surrounding areas.

On a brighter note, resurfacing works into the village have now been completed, along with a new pavement leading to Starbucks, which has been a welcome improvement.

The developments at both the old Paul Headlands land and Manor Farm are moving forward positively, with restoration work progressing well.

Concerns raised around noise and nuisance at The Old Vicarage have been addressed by Cllr Wright, and the responses so far have been encouraging.

It's also been wonderful to see the Village Hall busy with events recently, bringing people together in the community.

Finally, I'm pleased to confirm that the Christmas lights switch-on will take place on **Sunday 30th November**. The Hall will be open from 4.30pm for food and drink, with the official switch-on time to be confirmed.

- 4. Old Vicarage please see separate email from Caravan Assoc. Suggest monitor ongoing situation. Need a log of issues and then address if continue. Warning shot may suffice. This may be Environmental Health (EH) at Bassetlaw District Council (BDC) issue rather than County / Caravan association.
- 5. KW would like to hold a 'surgery' in the village. It would be good to liaise with PC to set this up
- 6. Travellers site no further action from me based on BDC assurances at last PC meeting.
- 7. Pavement area/trip case. Visited by KW. Agree the surface is crumbling. Inspected by Via not at threshold. Also KW walked the paths and most are in a similar condition
- 8. KW still await the bench details re Councillors' divisional fund (CDF) donation

#### District Cllr Charles Adams -

Sorry for late apologies however, I am to be Proposing passing of the "adoption of the Elkesley Local Plan" at Bassetlaw Full Council tonight and it is important that it is passed forwards to you for referendum without further delay a there is talk of Local Plan support grants being withdrawn.

Apologies as above, however, note the six months planning appeal time against BDC Planning Refusal for the Travellers Site is due to expire 25 October - I am in frequent meetings with Planning Officers and have got our MP involved in asking BDC why planning enforcement has not taken place- the most recent response 19th August from BDC Chief Executive is that "The applicant's agent contacted the Council with a view to re-submitting the application with a view to addressing the reasons for refusal. With this in mind it has not been expedient to progress with enforcement proceedings until this application has been submitted and decided" My argument to planning is that 6 months should be long enough for the applicant to gather the information and if necessary, make a revised application. Therefore, if no application is forthcoming by 25 October 2025 then enforcement should commence to remove the unauthorised and failed planning application site. I strongly recommend that Elkesley Parish Council should press BDC for similar commitment.

### 2328/25) To suspend the meeting to hold a 10-minute public session

A resident reported that following excessive dust and noise from Plevins site, complaints to EH and gone unanswered. Cllr Skelton proposed a letter be sent from the Parish Council. Concerns were also raised about the effect of the Unitary Authority.

It was requested that BDC were proactive in action regarding the August bank holiday rave. Comments were made regarding cars parking on pavements in the village making it difficult for mobility scooters etc to pass. The parish council will look into what action can be taken. Fallen trees at Crookford had been reported to the Forestry Commission, with a follow up email planned to FC and Environment Agency.
