Send the annual return, together with the bank reconciliation as at 31 March 2016, an explanation of any significant year on year variances in the accounting statements, **your notification of the commencement date of the period for the exercise of public rights** and any additional information requested, to your external auditor by the due date.

Your external auditor will ask for any additional documents needed for their work. Unless requested, do not send any original financial records to the external auditor.

Once the external auditor has completed their work, certified annual returns will be returned to the smaller authority for publication or public display of Sections 1, 2 and 3. You must publish or display the annual return, including the external auditor's report, by 30 September 2016.

It should not be necessary for you to contact the external auditor for guidance.

Matters reported

Section 1, Assertion 4, Exercise of Public Rights 2014/15 - Notice of Appointment of Date for the Exercise of Electors' Rights

We note that the announcement date on the Notice of Appointment of Date for the Exercise of Electors' Rights was only three days prior to the commencment of the inspection period. The Council then allowed 21 working days for the inspection of the books and records.

The Accounts and Audit (England) Regulations 2011 required that the Notice is displayed for 14 consecutive days before the start of the inspection period. The inspection period must be 20 working days. In our view the correct response to Assertion 4 on Section 1 of the Annual Return is "No".

The Council must ensure that the inspection period is properly advertised in future years, and allows for the correct number of days for inspection.

Other matters not affecting our opinion which we wish to draw to the attention of Collingham Parish Council for the year ended 31 March 2016

High level of reserves

We note that the Council holds a high level of general reserves, approximately seven times the annual precept for 2015/16.

The Council should review the level of general reserves required and consider taking steps to reduce the level in future years if necessary.
