When the previous application was put for the adjoining houses the residents asked if the track, now been proposed for this application, could be used as the entrance but it was stated on the response, by planning, that this track was not owned by the developer which it, in fact, is and was. The Clerk is to query this with the planning and enquire if this can this be reviewed or whether it is all 'done and dusted'.
