Minutes of the meeting of Tuesday 19th November 2019 At 7.00pm at The Redhouse Albrighton

19.085 Welcome by the Chairman:

The Chairman welcomed everyone to the meeting

19.086 Apologies for absence and reasons:

The above apologies were **accepted**, being proposed by Cllr Beechey and seconded by Cllr Jones, **all in favour**

19.088 Public Session:

There were no questions at this time.

19.089 Minutes

There minutes of the Council meeting held on Tuesday 15th October 2019 be accepted as a true record. **All in Favour.**

19.090 Matters Arising

a) David Austin Memorial

The cost will be about £1000. There is no further news on this project at present.

b) Flooding

Councillors noted that the Jessops development has failed in its appeal.

There was some discussion on the tree root removal in the area of the bridge and the improvement to flooding issues. Cllr Parry expressed the view that the right people seem to be talking to each other and that there will be a permanent solution to something that has caused the village a lot of problems.

Cllr Hickman noted that the Shropshire Council has appointed a Flooding Officer.

c) Disabled Access at Railway

A letter has been drafted to Network Rail, copying in R.A.F Cosford, about disabled access at the station. It was agreed to approve the letter, all in favour.

d) Boscobel House

The Clerk had spoken to English Heritage who had repeated their suggestion of using the venue for a Parish Council meeting next year. Councillors said this would be considered in future.

e) VE Day and VJ Day

Albrighton Parish Council will be discussing the proposal of dedicating a memorial bench to their meeting this week. Once an agreement has been reached by the two Councils, the next step will be to discuss with the medical practice about a possible location for the bench.

19.091. New Business

a) Scouts Heritage Grant Request

Albrighton Scouts are applying for a heritage grant and are seeking a letter of support from the Parish Council as part of this process. Financial support is not being requested from the Council, it is note the contribution and value of the scouts to the local area. Councillors agreed to send a letter of support of the contribution the scouts make to the local community, all in favour.

b) Red House Christmas Party

Councillors commented that the OAP Christmas Party was a good event last year. This year it will take place on 21st December. A donation from the Parish Council would be appreciated, it was noted that last year £300 was offered towards the event. It was proposed by Cllr Hickman, and seconded by Cllr Jones, that £300 should be offered as a contribution towards the pensioner's Christmas Dinner, **all in favour.**

19.092. Correspondence: For Action.

a) SSAFA (the armed forces charity)

The Chair, Cllr Williams, said the information sent about VE Day 75th Anniversary Celebrations had been an interesting read. He reported that Albrighton British Legion intended to put on events as part of the national Friday 8th May Bank Holiday commemorations. This would include a church service where a new standard would be dedicated, and a village parade. It is likely that R.A.F Cosford will send a contingent.

b) SALC Social Media Policy

The Chair, Cllr Williams, said that the social media policy was something that was needed by the Council. Subject to the Clerk removing the reference to a quarterly newsletter, which the

Council does not have, and personalising it, the policy should be adopted. It was decided to adopt the social media policy, all in favour.

c) BT Telephone Box

Subsequent to the Parish Council expressing an interest in adopting the telephone box on Shackerley Lane, Shropshire Council has sent a FAQs sheet and maintenance information.

Cllr Williams said that as interest had been shown in adopting the telephone box, some thought was needed on what it could be used for, it would be good if it were on a tourist route but it is somewhat off the beaten track.

Cllr Parry said that all that is needed would be for it to be painted every 5 years. Cllr Hickman said it would need PAT testing, Cllr Kirton said if it were moved the Council would need to pay to deal with the electrics. Cllr Williams said that this could be addressed and the cost would not likely be high, if adopted the telephone box would be an asset of the Council.

It was agreed to adopt the telephone box. All in favour.
