22.63 Chairman's Welcome and Announcements

The Chairman welcomed everyone to the meeting

Martyn Bidgood has moved to 'pastures new' and has resigned from the Council. Thanks were given for his sterling work over the years. There was regret for his leaving.

22.64 Apologies

It was resolved to accept an apology from Cllr Giles Greenwood

22.65 Disclosable Pecuniary Interests

There were none at this time

22.66 Dispensation

There were none at this time

22.67 Report from Shropshire Councillor

i) Solar Farm

Cllr Richard Marshall reported the Solar Farm is not on the Southern Planning Committee for November. He is no longer on the Committee as he now holds the Portfolio for Highways and Regulatory Services, and this includes planning in its remit. He noted that there were currently 19 solar farm planning applications across the county. Government legislation leans more to accepting them than refusing them, however, the Kemberton Solar Farm plan has strong material objections raised against it. If it doesn't pass it is likely that the applicants will appeal. Cllr Marshall said he would continue to fight against it, as it is in his view in the wrong location, and is half a mile from a brown field site. It's the location of the development, not being against renewable energy.

Cllr Phil Jones asked if the Parish Council giving a three minute presentation at the planning hearing would be worthwhile. Cllr Marshall said that in his view it would be, he also suggested an extra-ordinary meeting before the plan is discussed at Shropshire Council to prepare for it.

ii) Quiet Lanes

Cllr Marshall said that he was still keen on the quiet lanes suggestion but advised that it is a long-winded process and requires investment. Shropshire Council not being awash with money, and he suspects that the Government will not increase allowances for next

year so there could be some hard decisions to make as inflationary pressures will hit the Council as elsewhere.

iii) Affordable Housing

An affordable house built in the village has never been lived in. This is now in the hands of Planning Enforcement.

It was agreed to contact planning enforcement over a property in the village within the Conservation Area being rendered without it being cleared if necessary permission has been sought.

- b) Shropshire Council Streetworks: Field Lane will be closed between 7th and 9th November for repair between 9.30 and 16.00 it was noted that this work has now been completed
- c) The Chairman had received a letter from a resident that he read out. This expressed concern at the speed of vehicles passing through the village. Although it was recognised that the village is national speed limit of 60mph, drivers should drive to the conditions not the speed. Walking and driving down lanes can be dangerous.
- **d)** The Chairman had received a letter from a resident intending to write a history of the village. It was agreed that the Chairman should write Back offering the support of the Parish Council.

22.76 Environment

The Parish Clerk reported that Shropshire Council had sent notification that no further action would be taken about overhanging hedges by Polo Cottage.

22.77 Highways

In response to the resident's letter (22.74 c) solutions were discussed including quiet lanes and reduction of the speed limit. Cllr Richard Marshall noted that reducing the speed limit takes about 18 months and cost between £60k and £80k for a short stretch of road. Non-enforcement of the speed limit is also an issue in its effectiveness. Whilst he is hoping to get grant funding for the quiet lanes programme, the whole process will be slow. He advised speaking to the Road Safety Officer at West Mercia Police for suggestions for raising community speed awareness.

Cllr Mark Lea noted his disappointment at the lack of support from Shropshire Council when it was approached to approve a plan for Kemberton Junction that had financial backing from West Mercia Police. He questioned if Shropshire Council would be similarly unsupportive in any future endeavours.

It was agreed to contact West Mercia police and formulate a Working Part to see what can be done to improve community speed awareness.

The Chairman, Cllr Phil Jones, said he would write a note in the village newsletter about speeding.

22.78 Other Parish Matters

The Chairman, Cllr Phil Jones, said that he had made contact with a company that makes Silent Soldiers and donates to the Royal British Legion. It was closed this year but is something to consider for next year.
