18. Broadband

Cllr M Lea has received an email from M Moss which he read out at meeting. (Extract from email). "I asked Chris at Connecting Shropshire a few weeks back. He said they have been very busy closing down contracts on Phase 1. Phase 2a is about to start, and he stated we are part of that. I'm not sure where we are on the list within that, but he said there is a lot of planning to take place, and he'd inform us when they get to that point. Stage 1 will be BT carrying out a ducting survey, which originally was due to happen this spring. I'm not sure if that was a bit ambitious, but maybe we should press him again in spring as see what stage they are at. Then he stated a view to install winter 2017/2018. I see they put out an email this afternoon that states Phase 2 starting this month, and completing spring 2018."

The Chairman thanked Cllr M Lea for update and said it would be interesting to see what comes out of Connecting Shropshire's evaluation for installation.

19. Appointment of Internal Auditor
