UNDER THE LOCAL GOVERNMENT ACT 2000 AND THE LOCAL AUTHORITIES (MODEL CODE OF CONDUCT) ORDER 2007 (AS APPLICABLE TO PARISH AND TOWN COUNCILS)

- 7. Gifts and hospitality
