1. APOLOGIES

Apologies were received from Cllr Roger Jackson (Newark & Sherwood District Council and Notts County Council).

2. DECLARATIONS OF INTEREST

There were none.

3. MINUTES FROM PREVIOUS MEETING

Held on November 27th and December 18th were agreed as a true record and were signed by the Chairperson.

4. TRAFFIC & HIGHWAYS MATTERS

Members reported that the slope road was, in parts, overgrown with grass. Also reported was the fact that the A6097 verges between the Bridge and Main Street were building in height due to cut grass rotting and turning to soil. TC to report both these matters to NCC.

5. ENVIRONMENTAL MATTERS

A brief questionnaire has been received from Emergency Planning at NSDC regarding flood and snow wardens – Cllr Everington will complete and return. Information on CCTV's has been received from a private supplier – Members agreed that this is a matter for businesses and individuals and not for the Parish Council.

Maintenance and possible repairs of the main drains, especially under Main Street, was discussed. TC informed Members that he had been trying to contact Adam Boucher of Severn Trent Water since September and had recently contacted Notts County Council. TC to pursue.

6. THE RIVERSIDE PROJECT, GRAVEL EXTRACTION AND FLOOD ALLEVIATION

With regard to the land purchase, various communications from Ian Torr and FraserBrown (the Anglers' Solicitor) were discussed. It was reiterated that the issues that had arisen were due solely to the fact that the Anglers had lost the deeds to the land and that the Parish Council should not be responsible for paying the Anglers' legal fees over and above the initially agreed amount.

A member of the public asked why land was being purchased from the Anglers and was informed that the purchase has been agreed at a public Village meeting and that it was inappropriate for discussion at this meeting.

TC was asked to raise with Ian Torr the subject of the Common Land.

Cllr Bowles stated that the Cocker Beck had overflowed onto land adjacent to Cottage Pasture Lane and Grange Farm last week. Cllr Bowles had notified the Drainage Board. It would seem that a drainage pipe which would have helped avert this situation was too small and that Severn Trent Water had been notified.

It was reported that Dr Andy Harrison and others had attended a meeting with the Environment Agency. Further site investigation and consultation were needed. There is to be another meeting to which a member of GPC is invited.

7. Public Discussion

A member of the public, Amanda Howell, asked what was being done to improve the appearance of the Common Land. Cllr Jeffery replied that GPC was in communication with the various landowners who were not being very helpful. With regard to the overgrowth near the water's edge Ms Howell suggested that if permission to cut this back was not available that the PC should simply get the work done. The landowners were unlikely to complain about the land being more presentable. Cllr Bowles is meeting with RC Services to discuss other matters and will ask for a price for carrying out this work.

A report was received from a resident, Graham Marshall, regarding the street lighting on Trentside. It would seem that lights are regularly failing and that at one time, at least, all three lights were off. TC has reported this problem, but Mr Marshall was informed that any member of the public could report lighting problems to Notts County Council (online or tel 0300 500 80 80).
