The Chairman mentioned that leading up to this meeting and confirmed in his report to the committee on 28th May 2019 'It had been agreed by both the FRGC and the FPC and had been voted on and accepted' Since then a legal document had been drawn up following the presentation of three possible formats. This draft resolution was chosen unanimously and had since been voted on and accepted by the PC on May 4th 2020.

Damian Greenish a PC Councillor had been invited to the meeting to answer any questions, particularly of a legal nature, that members of the Committee might have on the future roll o FPC as Trustee. He did not otherwise take part in any business of the Committee.

The Chairman confirmed that the FPC, in forming a sub committee responsible for the day to day running of the Recreation Ground and Playground, had been asked to see that the members of that committee be representative of the main users. He was also pleased to report that John Shaw had already agreed to be part of that sub committee which, in the Chairman's opinion, would be of enormous help to the FPC with all his experience particularly as Treasurer and Bookings Secretary.

The Chairman asked if there were any questions but none were forthcoming, he confirmed he was 100% in support of the Resolution and asked the Committee if they would give it their approval. This approval was then given unanimously.
