Frindsbury Extra Parish Council objects to this application, for the same reasons it objected to a previous similar application on this site, which is no longer shown on your website and may have been withdrawn before determination.

The area available is too small to accommodate 3 flats and it is therefore an over intensive use of the site. The Council also believes that the one bedroom flat is a smaller area than currently permitted. The parking space is totally inadequate and would encourage residents and visitors to spill out onto the street, which is already clogged with parked cars, both day and night and causes problems for traffic in Wainscott Road, especially buses . Cars for these flats forced to seek parking on the road would only add to the problem.
