*Concerns about new play area. Clerk reassured the resident that there were no actual plans in place to re-do the play area, but we had requested that the company who carry out the safety check have a meeting to give any recommendations which might benefit improving any of the existing equipment.

*Tree planting. The resident was also concerned that a further traveler incursion might happen and suggested tree planting on the edges. Clerk reassured her that if any bollards were removed in order to gain access onto the Green, it would be a criminal offence. Also concerning noise, it would take two Hundred yards of undergrowth in order to make any difference to sound.
