### **East Drayton Parish Council**

Minutes of the Parish Council meeting held at 7:00pm

on Tuesday 22<sup>nd</sup> January 2019 in the Village Hall

**Present**: Cllrs N Stanley (Chairman), A Stanley, D Jopling, R Small, M Goddard, I Stephens; the Clerk; CCllr J Ogle. Members of the Public: 4

- 1. Apologies for Absence: Cllr Mackintosh
- 2. Minutes of the meeting held on 27<sup>th</sup> November 2018 approved and signed.
- 3. To consider matters arising from the above minutes:
  - 1. "It's 30 for a reason" now displayed on Church Lane and Low Street.
  - 2. Planning see below.
  - 3. Cllr Stephens is investigating the possibility of Sports Funding for the Village Hall.
  - **4.** There were no further matters arising.
- 4. Declarations by Councillors of any disclosable pecuniary interest(s) in any agenda item. None.

## 5. Planning -

- Application 19/00029/FUL The Paddock, Long Lane, East Drayton "to retain change of use from equestrian to a single pitch traveller site". The Chairman explained that in 1995 BDC gave permission for a hard standing exercise area for horses on this site. In 2004 permission was given for the erection of one brick building comprising of a stable and tack room for 2 horses. The current application is for one static and two touring caravans and associated vehicles. The Parish Council agreed the following response that the application is not supported for the following reasons-
  - 1. Concern that there are no services.
  - 2. At the time of the application there are 5 caravans on the site (permission for 3 caravans one static and two tourers requested).
  - 3. If BDC approve the application would they monitor the number of caravans and vehicles on site?
  - 4. The use of the building as a dayroom, when it is a stable and tack-room.
- A query was raised as to whether or not planning permission had been sought (or was necessary) for a double field gate and the erection of a hay barn in a field opposite The Grange. Chairman to investigate.
- The Chairman brought to the attention of the meeting the Draft Bassetlaw Plan, which now includes East Drayton with an additional housing requirement of 10 dwellings between 2018 and 2035 (capped at 20% or 19 dwellings).
- **6. Correspondence** see attached sheet. Plus a letter from BDC regarding the Bassetlaw Spring Clean, to be held between 1<sup>st</sup> March and 31<sup>st</sup> May the Clerk to respond and order bin bags from the BDC.

# 7. Urgent Business -

- Parish Council elections are to be held on Thursday 2<sup>nd</sup> May 2019. The Clerk asked the councillors to confirm their wish to stand again (or not) by 1<sup>st</sup> March. The notice of the election will be posted on March 26<sup>th</sup> and nomination papers will be distributed to interested persons from then, with a return deadline of 3<sup>rd</sup> April.
- The Annual Parish Meeting will take place on Monday 20<sup>th</sup> May at 7pm.
- The estimates form for the Parish Precept (2019-20) was presented to the meeting. The Clerk explained that due to increased expense in the last financial year tree pollarding; purchase of a heavy duty strimmer; purchase of the defibrillator and box; purchase of a new notice-board for the churchyard and a large donation to the Village Hall this amounted to an increase of 128% on the previous year's spending. It was agreed that the PC would request an increase of only 5% on the annual precept cost to council taxpayers.

## 8. Meeting adjourned for public discussion –

- CCIIr Ogle further explained the impact of the Bassetlaw Draft Plan on housing in the
  area, with a target of 7% increase in housing stock. Concern was expressed at the
  levels of sustainability in smaller villages like East Drayton with a lack of sustainable
  services.
- CCIIr Ogle commented on the repair to the verges and drains on Bingham's corner
  on the Retford road and noted that the drainage issue opposite Church Lane Farm
  would be addressed this year. The Chairman again commented on the deterioration
  of the road from North Green to Stokeham.
- Stating that there was now a dedicated police officer, PC Gareth Mitchell for this area (but based in Harworth), CCIIr Ogle noted that there was now specific training for rural policing through Operation Bifocal. Rural crime has increased by 30% in the last year with the force greatly stretched. It was noted that local farmers are suffering frequent incursions into their yards during the early hours and that police response is inadequate. CCIIr Ogle invited all interested parties to attend the quarterly policing meetings at the Town Hall and to put their concerns in writing to Inspector Rudd; the Chief Constable and the Police Commissioner.

A committee is to be set up to plan and run various activities throughout the day. It was agreed at the previous meeting that funds would be set aside to support these activities.
