050/1516 PUBLIC SESSION

Following on from a presentation from Chris Taylor, Connecting Shropshire to the Tern and Severn Valley LJC meeting, Cllr. Nelson expressed the parish's concern that most of the other 14 parishes in the LJC have a "solution" whereas this parish does not. Cllr. Nelson asked Cllr. Wild if it would be worthwhile creating a pressure group to campaign for parishes such as Wroxeter and Uppington. Cllr. Wild suggested writing to Chris Taylor (Connecting Shropshire), Shropshire Council Leader, Keith Barrow and MP Daniel Kawczynski. The council also noted that the Prime Minister unveiled a new initiative for delivering an effective broadband solution for the "final 5%" by 2020", although it is unclear what this means for the parish.

#### 053/1516 REPORTS

Cllr. Wild outlined the budgetary pressures Shropshire Council faces. It has saved £149 million since 2009. Over the next five years, it needs to save a further £77 million. Contributory factors in this include the ending of the revenue support grant from central government in 2020/21, the increase in adult social care costs and the fact that council tax has not been raised for 8 years. The predicted budget for 2020/21 is estimated to be £188m, of which £163m (87%) is core services such as adult's and children's social care and safeguarding, domestic waste disposal, concessionary travel and school transport. Shropshire Council now needs to decide which services it can continue to provide and will be holding a consultation exercise with the community, "The Big Conversation".

# (a) Connecting Shropshire update

The Council was unanimous in expressing its concern that whilst being a very considerable way through a sequence of government-supported broadband programmes within the County, there is as yet no firm plan being put forward regarding improvements for this Parish other than "Exploring Solutions". The council felt it must press its case now in order to secure a viable broadband solution for the Parish before the currently known tranches of funds are exhausted.

It was therefore **RESOLVED** that the council write to Chris Taylor, Keith Barrow and Daniel Kawczynski to request meetings and answers to the following points:

- Provision of a map of the Parish with all of the relevant Telecomms infrastructure clearly detailed and shown in relation to the location of premises within the Parish.
- The precise quantitative criteria used to decide which areas have so far been allocated FTTC or FTTP solutions, supported by a detailed analysis of how Wroxeter & Uppington scored on each of those criteria compared with areas at the bottom of the scale of those which were successful in being allocated FTTC/FTTP.
- Which of the alternative technologies and modes of implementation have been considered for the WUPC area and which of these are currently the most likely one(s) to be offered to the parish? When will the parish know which technology is to be offered and to what extent can it have an influence in the final choice.
- Picking up on the point from the LJC presentation that no more than 0.5-1.0% of Shropshire properties are expected to be allocated the expensive, problematic and inferior satellite option, the council would like to know the maximum number of properties within the WUPC area which it is expected will fall into this category.
- The LJC presentation referred to the possibility of part of the WUPC area being served by T&W. WUPC would like to know how far these discussions have been taken and who to speak to within T&W in order to be kept up to date with any developments on this.
