BRANDON TOWN COUNCIL

Minutes of the Full Brandon Town Council Meeting
Held on Monday 7 November 2016
In the Council Chamber, The Old School House, Market Hill, Brandon at 7.00pm.

The meeting commenced at 7.00 pm.

1. APOLOGIES FOR ABSENCE and approval of reasons tendered.

Cllr. L Jacobs, Cllr. E Jacobs, Cllr. G Hughes.

2. DECLARATIONS OF INTEREST and additions to Members Register of Interests. None.

3. CLERK'S REPORT

Questions raised included the response to the advertisement for a temporary town keeper (for truck insurance requirements, age of applicant needs to be 25+); commemoration bench (Slo Zap adhesive recommended to secure the plaque to the bench); training for tree maintenance; large bush (box) in closed cemetery necessitates heavy pruning; Calder's Close (no update from FHDC); designated zones (not a byelaw); clerk's report to be circulated to the public along with the agenda.

A report from RAF Lakenheath was now heard.

4. PUBLIC FORUM

Matters raised included the station crossing; replacement trees on London Road; HGV's causing heavy pollution in Brandon; update on new cemetery (still commercially sensitive); Brandon Day Care Centre (hopeful a new provider has been found); employment of person to assist the town keepers; tarmac path around Evergreens; whether a decision has been made to demolish the old community centre (no plans to date); support for a Polish Memorial; the illegal use of large lorries still using Small Fen Lane (bridleway); traffic flow information (no results as yet, RS to follow up); could the crane be used to position new permanent lights whilst being hired to take down this year's Christmas lights?; support for training enabling our groundsmen to maintain the trees in the Cemetery and Victoria Avenue; issues of drinking and drugs at the play area at Wood Close and Yew Drive; town clock light not working (service due imminently); The Lode (still to be investigated).

A report from RAF Lakenheath was now heard.

7. TO RECEIVE A REPORT FROM RAF LAKENHEATH

Little to report other than an increase in aircraft noise due to easterly take offs. An apology was given that there has been no public notice of recent night flying. A question was asked relating to parachutists on RAF Lakenheath – confirmed as a training exercise.

6. MATTERS ARISING

Prior to the trees being planted on London Road, Cllr V Lukaniuk offered to mark where they are to be planted. If practical, our groundsmen to carry out the work. A licence to plant on the highway has been applied for and permission granted. Cllr. P Ridgwell asked why it was not possible to get the results of the traffic count from Highways England (RS to investigate).

Agenda item 15 was now heard.

15. PRESENTATION FROM BRANDON IN BLOOM REGARDING THEIR PROPOSED PLANS FOR VICTORIA AVENUE

Proposed plans for Victoria Avenue include removing all overgrown greenery; to make good the flint wall; to utilisie the cast iron 'air raid pole to create a pole; signage and lighting in a similar style as to the arches already in place (sketch circulated); to provide at least one planter, a dog bin and waste bin; to restore the current arches to as near to the original finish as possible; seating to be sited at midway point. All work to be funded by local fundraising and at no cost to the Town Council.

Other projects may include: Best Container, Best Garden, Best Wheelbarrow (as in previous years); refurbishment of the Brandon War Memorial.

8. TO RECEIVE REPORTS from County and District Councillors, Community Group Representatives. No written reports were received. Cllr. R Silvester stated the drains located just before the barrier at the Aldi car park were not in fact owned by Suffolk County Council, but by Aldi themselves. Therefore, any costs to clear them could not be met by Cllr. R Silvester's Highway's locality budget. Cllr. P McLoughlin said the piece of ground in question (at the bottom of Lode Street) is privately owned and anyone receiving parking tickets should look at the validity of those tickets.
