# **East Drayton Parish Council**

Minutes of the Annual Meeting of the Parish Council held at 7.30pm on Tuesday, 15<sup>th</sup> May 2007 in the Village Hall

### Present:

Cllr D Allen (Chairman), Cllrs M Ogle, J Parker, H Shreeve, P Ogle, J Goddard, R Small, CCllr J Hempsall, PC Bailey and PCSO Tony Ciacci. In attendance: S Pickard (Clerk). There were no members of the public present.

1 Apologies for Absence – There were no apologies.

The Clerk took the chair and asked for nominations as follows:

#### 2 Election of Chairman

It was PROPOSED by Cllr Ogle and SECONDED by Cllr Shreeve that Cllr Allen be re-elected Chairman. ALL AGREED.

#### 3 Election of Vice-Chairman

It was PROPOSED by Cllr Allen and SECONDED by Cllr Shreeve that Cllr Ogle be re-elected Vice-Chairman. ALL AGREED.

The book of Declaration of Office was duly completed and signed and Cllr Allen took the Chair.

The Chairman welcomed PC Bailey and PCSO Tony Ciacci to the meeting. PC Bailey introduced PCSO Ciacci who works with him and as PCSO his role is one of high visibility and reassurance and to try to be available wherever there was a problem. Recently PCSO Ciacci, who is on foot patrol, has been involved with issues in Tuxford and Laneham, and PC Bailey assured the meeting that he would be available for East Drayton should a problem arise. PC Bailey said since 1<sup>st</sup> January 2007 there have been six crimes in the village (these had been mentioned previously in PC Bailey's crime reports). The incident concerning harassment of a female was clarified as one of mobile phone misuse by a man in Chesterfield, (as referred to in last month's Minutes). PC Bailey warned of periodic opportunists coming into the village looking for anything to steal and he urged anything suspicious be reported. PC Bailey said that links with Neighbourhood Watch had fallen down recently due to office staffing issues and he had to look for the information himself. PCSO Ciacci said there was an unofficial system in operation whereby neighbours ring round themselves.

The Chairman thanked PC Bailey and PCSO Ciacci for their attendance and they left the meeting.

# 5 Minutes of meeting held on 17th April 2007

The minutes of the above meeting were approved and signed as a true record.

### 6 Matters Arising

## a) Environmental health issue at Vine Farm

The Clerk reported no replies to date had been received from Mr John Bowler at Bassetlaw District Council or Mr Geoff Betts at Severn Trent Water regarding the request to consider cooperating together to establish the whereabouts of the drains at the bottom end of Low Street. It was therefore AGREED to contact the Chief Executive at Bassetlaw District Council to advise him that no response had been received from his Council. It was also AGREED to contact the Consumer Council for Water to update them. **ACTION: S Pickard.** 

# b) Rampton Hospital Community Forum meetings

The Chairman and Cllr Ogle attend the meeting held on Thursday, 26<sup>th</sup> April. The Chairman reiterated his comments that the meetings were just a paper exercise. The new Chief Executive is Mr Mike Cooke and new Director of Human Resources Manager is Kate Truscott. The Chairman reported as follows:

- Proposal of new Northern perimeter fence likely to cost £32.9m.
- Parish Council's letter sent concerning the suggestion that the Forum meet less frequently was not received and although discussion followed, three-monthly meetings will still take place.

Community Forum did agree to hold future meetings outside the prison in the Community Centre which would alleviate the necessity for lengthy security checks.

### c) Nottinghamshire County Council request re Back Lane

The Clerk advised there had been no response to date concerning the second request to Nottinghamshire County Council to repair the surface of Back Lane. CCllr John Hempsall had taken this matter up on the Parish Council's behalf and he AGREED to pursue the matter.
