5. Football Foundation Update Report

Lee Suter led the discussion

• Site Inspection report – issues

Obviously Weald Clay and drainage on the site is an issue Main Drain – requirement for an easement – may be better to move pitch Northwards as this can take a long time for permission regarding easements Need to clarify SECFL ruling on adjacent pitches Need to finalise location of 3G and the grass pitches around them – do not want to lose another grass pitch if possible

(Ross Andrews to review and bring back location of pitch – ASAP – to be agreed)

It would be great do this by end of May so it can go to Parish Council 5th June 2023

Next steps

Once location confirmed

Football Foundation to use "Framework" to tender

Make recommendation July / August 2023

Council will need to approve – provide "written authorisation" – this is a commitment to the project

Followed by "Kick off" meeting with all partners (should this include MBC / KCC in pre-application meeting)

At same time start consultation programme – see below

Finalise design

Aim to submit planning application autumn 2023

At same time work on developing business plan from now until submission – (CR lead)

Realistic timetable

Subject to planning aim for bid submission January 2024
Football Foundation decision – Spring 2024
Contractors on site summer 2024
Open autumn 2024
Maybe – pushed back if planning takes time

Council costs

Council committed £10,000 and appointed CSLL

Some underspend from last year – consider allocation of Parish Council reserves and report to 5^{th} June 2023. Potential planning fees £10,000 and Legal Charge £2,000.

Lee Suter confirmed no other costs anticipated

Fund raising

Important Parish Council "should" cover any professional fees, legal costs (consider from reserves) so that club / community fund raising focuses on the actual 3G all-sports pitch itself

8. Some general questions

NS — Why should the football clubs do fund raising? Lee Sutter as a partner in the project there will be a need to be Service Level Agreement signed off by Clubs, Council and Football Foundation which will include priority bookings and discounted rates

NS – If 3g pitch moved northwards – could lose another grass pitch? Aim is not to lose an extra grass pitch – Sport England statutory consultee. Important factor in design of site

LS – concern about match fees on the 3G pitch? This will be part of developing the business plan and feed into SLA.

LS – Impact of 3g on the remaining grass pitches? Part of the design process – involve groundsman in "kick off meeting" local knowledge vital

LS – Concern about impact of 3g on access / maintenance of remaining pitches? Part of the design process – involve groundsman in "kick off meeting" local knowledge vital

NS – Concern about car parking

Lee Suter if planning condition then can include in Football Foundation project costs. Also about general feel of site

NS – Security an issue in rural isolated site All agreed an issue

Louise Brice concluded obviously we need to work through these together as a team CR to pull together a spreadsheet / action plan / GANT chart to help the team stay on track
