**1. Apologies:**

Apologies were received from Cllr Ellis, Cllr Clarke, Cllr Smith, Cllr Field (MBC), Cllr Fitzgerald (MBC), PC Stuart Thomas.

The Chairman recorded the death of Ray Slingsby, a resident who for many years ran the Boughton Monchelsea scout troop who died suddenly on the 14 April following an accident. The funeral is to be held at St Peter's Church, Boughton Monchelsea on the 3 May.

**2. Elections:**

2.1 Chairman: Cllr Ellis (in absentia); Proposed by Cllr Marsh; seconded by Cllr S. Munford and agreed unanimously. It was further agreed that the Chairman's Declaration of Acceptance of Office could be signed at a later date.

2.2 Vice Chairman: Cllr Marsh; Proposed by Cllr S. Munford; seconded by Cllr Bray and agreed unanimously. Cllr Marsh remained in the chair for the rest of the meeting.

**2.3. Appointments:**

2.3.1 Planning and Licensing Committee: Cllrs M. Bray, A. Boden, W. Clarke, (in absentia) K. Filmer, R. Fuller, J. Marsh, N. Mitchell, S. Munford and I. Smith (in absentia) agreed to stand.

2.3.2 KAPC Representative: Cllr Ellis (in absentia).

2.3.3 Village Hall & Recreation Ground Committee Representatives: Cllr Bray and Cllr S. Munford agreed to serve as the Council's representatives.

2.3.4 Allotment Representative: Cllr Filmer agreed to serve as the representative.

- 2.3.5 Neighbourhood Watch Representatives: Cllr Marsh and Cllr Bray agreed to serve as the Council's representatives.
- 2.3.6 Web site co-ordinators: Cllr Boden and Cllr Mitchell agreed to serve as the representatives.
- 2.3.7 S&W Maidstone Traffic Management Partnership (TRAMP) representatives: Cllr Herrin and Cllr Bray agreed to serve as the Council's representatives.
- 2.3.7 Local Board Representative: Cllr Herrin agreed to serve as the Council's representative.
- 2.3.8 Highway Liaison: Cllr Herrin agreed to continue.

3. **Notification of late items for inclusion in the agenda:**

Members agreed to the inclusion of item 12.2 as a late item and the additional papers on items 5 and 14.1.3.

4. **Exempt Items (Standing Order 61):**

Members' agreed that the public and the press should be excluded from the meeting during any discussion on Item 14.3 on the grounds that matters of a confidential nature may be discussed.

5. **Maidstone Police and Rural Warden Reports:**

A representative of Kent Police was not available. Crime figures from Kent Police for the period 7 March to 1 May were tabled as a late item.

Mrs Roots reported that KCC will be introducing its 'Handy Man' service shortly. This will be a free of charge service for vulnerable persons who need, for example, locks fitting to improve security and home adaptations to allow patients to be discharged early from hospital: Cllr Fitzgerald has funded a work experience placement for an adult with learning disabilities to litter pick in selected areas in the village: The village hall car park is being used for drug taking – the matter is being dealt with by Kent police: Damage to the phone box again has been reported to BT to repair: The complaint by a resident in Brishing Lane of nuisance motorbikes on Furfield Quarry is being investigated: Lorry parking in Meadow View Road is being investigated for possible traffic violations.

Mrs Roots gave her apologies for not being able to attend the Annual Parish Meeting. A report will be submitted to the Clerk.

6. **Open Quarter:**

- 6.1 John Phillips: Mr Phillips complained at the lack of action by KCC to fill in potholes in Brishing Lane and Green Lane. Cllr Herrin advised that the particular holes had been reported, but as usual, getting KCC to action the reports was proving difficult. Cllr Mitchell reported that at short notice KCC had commenced work on resurfacing Back Lane and queried why more deserving roads weren't being done.

Cheryl Price: Mrs Price attended to advise members how the church youth club was progressing now it had been given a permanent home in the cricket pavilion. Ms

Price outlined the club's activities and how the interior of the pavilion is in need of refurbishment. The club meets regularly now on a Friday night at the pavilion and is attracting a good attendance. Ms Price requested members to consider the youth club for a grant.

David Sayers: Mr Sayers spoke to amplify the vicar's request for additional grant towards the cost of grass cutting and maintaining St Peter's churchyard. The PCC is endeavouring to keep it maintained in accordance with how residents would wish to see a churchyard where their relatives were buried but there is a cost attached which is becoming an increasing burden on the resources of the PCC. The alternative is to reduce the maintenance which presumably is not the wish of members or residents. Mr Sayers explained that the volunteers who currently maintain the churchyard extension are no longer able to cope and its maintenance is to be put out to private contract. Mr Sayers reminded members that the churchyard is still open for the burial of any late resident of Boughton Monchelsea. It also serves as a major amenity for residents and non residents. Estimates from the grounds contractor for maintaining the churchyard for 2007/8 were made available to members.

**7. Declarations of Interests:**

Cllr Marsh asked members if they had any interests to declare in respect of any item on the agenda. Cllr Filmer declared a personal interest in Item 14.1.3 when considering any grant to the scouts as Cllr Filmer is now joint troop leader. Cllr Boden declared a personal interest in Item 14.1.3 when considering any grant to the scouts as he is treasurer to Maidstone South District Scout Council.

- 7.1 The Local Authorities (Model Code of Conduct) Order 2007 – Adoption: Cllr Marsh advised members that the Parish Councils (Model Code of Conduct) Order 2001 under which the Parish Council currently operates is revoked (but remains in force) until Councils adopt the 2007 Code. Cllr Bray proposed that The Local Authorities (Model Code of Conduct) Order 2007 be adopted; seconded Cllr Mitchell and agreed unanimously.

**8. Minutes of the last meeting:**

Cllr Oliver and Cllr Munford did not agree point 3 below under Item 5, page 3 (LDF Consultation):

“3. Agree to the relaxation of the village envelopes to allow scope for some limited development particularly local needs housing.”

After much discussion, an amendment was proposed by Cllr Mitchell; seconded by Cllr Herrin to read:

3. Agree to consider the relaxation of the village envelopes to allow scope for some limited development particularly local needs housing.

Voting: 8 For; 0 Against; 2 Abstentions. Amendment carried

With this amendment, the minutes of the meeting held on 6 March 2007 were agreed and signed by the Chairman.

9. **Matters Arising:**

- 9.1 Albion Inn: The Clerk reported that he understood that a developer had bought the property; but that the pub is due to re-open on Friday 4 May.
- 9.2 Fly tipping: Cllr Marsh advised members of his experience regarding an incident of fly tipping reported and investigated by him. Firstly, do not remove any evidence of the identity from where the tipped material may have originated (couldn't be used in evidence) and secondly, ensure you obtain full details of the informant. Leave any fly tipped material where it is and report it to MBC or the Rural Community Warden.
- 9.3 Arriva No 59 Service: No meeting had been held yet regarding the Marlpit bus stops. Cllr Marsh had received a negative response from Arriva to the suggestion of a bus link between Boughton Monchelsea / Chart Sutton and Coxheath. He will pursue. Suggestion that the No 89 service could be re routed to take in the villages.

- 9.4 Kent Highway Service's (KHS) responses on action points from meeting 31.1.07:

Heath Road – variable speed limit at school: Still being looked at by Peter Rosevear KHS.

Visibility splay east – junction Church Street / Heath Road: Will be monitored in the event of a development scheme is brought forward.

Brishing Lane Footpath: Louise Rowlands (KHS) will be discussing with Peter Rosevear (KHS).

Brishing Lane HGV restrictions: 'Unsuitable for HGV's' signs will be provided at each end of Brishing Lane. This will be funded from LTP signing and lining allocation for this financial year.

Junction improvement Brishing Lane / Green Lane and Heath Road: Darren Hickman (KHS) is preparing a plan and this will be forwarded to the Parish Council once it is completed and a safety audit undertaken.

Crash barrier at bottom of Beresfords Hill: It will not be possible to erect a crash barrier in front of the ragstone wall in Beresfords Hill as this would be an obstruction to the highway. Members requested the Clerk to ask KHS to build out the kerbing from the wall to act as a 'first stop' for vehicles which skid on the corner. Members also requested that KHS clear the debris and growth from around the wall in Bottlescrew Hill to improve its width.

Erection of new detached dwelling to replace existing kennels and reinstatement of existing road

**DECISION:** Refuse on the following grounds:

1. The proposed development will be very cramped with little or no amenity space around the property to benefit the development.
2. The amount of natural light to the ground floor of the proposed dwelling will be limited due to the size of windows and the existing conifers to the west in the adjoining industrial unit to the detriment of the health and environment of any occupant of the new dwelling.
3. The development would harm the character and appearance of the area and the amenities of the surrounding occupiers, contrary to Policy ENV28 of the Maidstone Borough Wide Local Plan.
4. There is little evidence of an existing 'road' which if it was such appears to have long been abandoned. An additional vehicular access now would harm the amenities of the occupants of the adjoining property 'Heathcot' with additional noise and disturbance contrary to policy H19 of the Maidstone Borough Wide Local Plan.
5. The access will be by a very long and narrow drive to the side of Gentian to the detriment of its amenities and does not appear to be of an adequate standard for residential use.
6. The B2163 Heath Road is a secondary network road. Increased use of the access will result in a greater risk of accidents and collisions from emerging traffic.
7. The side entrance to Gentian is directly off the access which will be a hazard to drivers using the access and the occupants of Gentian.
