2. Trent Viaduct

- -Representative requested a visit to PC meeting to inform/explain their current works and aspirations for the future
- -Cleaning and painting is taking place now as a matter of routine maintenance; grant from Railway Heritage. No planning is required to maintain the listed structure and we were informed that no notice was required to be given of the maintenance being carried out
- -Decking is to be installed to the north side of viaduct next year; Railway Paths Ltd.
- -Aspiration is to create a traffic free pathway over the viaduct from Cottam to Torksey, safe to all users; cyclists, wheelchair, pedestrians, horse riders, all ages and abilities
- -There will need to be liaison with English Heritage and further support and funding will be required to consider this further phase of development and renovation

A lengthy discussion took place. Cll. Gamble was disappointed that he was not informed about the current maintenance program. He and others present referred to the previous occasion when suggestions were made to provide a safe pathway over the Trent Viaduct from Cottam to Torksey and the challenges to security of surrounding property that the project would present.

Representative for the project were disappointed that the Parish Council did not appear to support their work and aspirations. They were, however, encouraged to hold a public meeting to enable parishioners from Cottam and surrounding villages to learn more about their work and to obtain support for this project prior to submitting a formal planning application.
