19.25 Environment

i) Cllr Angela Blount said that she had put in another Fix My Street report about storm drains as the drain on Field Lane has blocked again.

It was agreed that the Parish Clerk write to Cllr Elizabeth Barker to update her on this issue and also about the overflowing cellar pipe that had also been reported on Fix My Street but not resulted in any positive action.

ii) Councillors expressed concern about a stone wall on Mill Lane that is covered in ivy and looks in danger of collapse. There was concern both about this as a

It was agreed that the Parish Clerk should contact both Shrosphire Highways and Shropshire Council's Conservation Officer about this matter, and copy in Cllr Elizabeth Barker.

20.25 Highways

Cllr Angela Blount said that the junction at Kemberton Quarters is overgrown with grass and could present a visibility road safety issue.

There will be a temporary road closure on Grindle Road on 15th July 2025, due to Openreach replacement of X1 Pole in the verge https://one.network/?tm=143122979
