The Friends of the Brickfield requested permission to erect two "Tommy Silhouettes" at the War Memorial mounted on two low plinths.

Cllr Beerstecher proposed permission be granted, seconded by Cllr Howard-Challis. Carried by four votes to one.

b) Parks and Leisure

It was agreed not to proceed with the Fields In Trust deed of dedication on the grounds that it did not provide the Brickfields with any more protection than was already covered in the covenants on the area. Proposed by Cllr Beerstecher, Seconded by Cllr Gates. Carried unanimously.

Negotiations are on-going in respect of the possible re-routing of the stream.

c) Docks and Barges

Quotes have been requested from two companies in respect of repairs to the Dock West Wall. Quotes have also been requested for fencing off the damaged area and will be circulated when received.

d) Burial Ground and Allotments

No report.

e) Footpaths Highways and Lighting

It was agreed that the contractor would be contacted to start the trial of new LED streetlights in an area where the light has been reported as not working.

g) Handyman

The gate at the recreation ground has been painted yellow and reflector strips put on it, to make it more visible after a recent accident. The Chair thanked Cllr Dadson for the work he carried out on this and for providing and installing the boards in respect of the dog waste bag dispensers.
