There was concern that issues with flooding and drains is getting worse. Cllr Mark Lea said that water was coming out onto a resident's driveway and causing damage. It was questioned if releasing water from a fish farm into storm drains was exacerbating the problem, and if the water should not go into the sewer system instead. The Parish Clerk said she would investigate this matter with the Environment Agency and report back to the Council.

# 52.25 Highways

- There was no update from the Conservation Officer on the village wall at this time. Cllr Mark Lea noted that a section of the wall has different ownership to the rest of it, and that he expected maintenance to carried out on this section in due course.
- ii) It was agreed to proceed with the quote obtained for Village Gateways and to use the £2890 of Neighbourhood Fund for this purpose. It was requested that the Parish Clerk ask for revised quote for slanted picket fencing and delivery. Cllr Mark Lea would speak to the company directly about instalment.
- **iii)** Cllr Giles Greenwood expressed his dissatisfaction with the quality of road repairs carried out on Groom Lane. Parts of the road have bene repaired but is not an overall substantial repair, with other sections of the road being left in a poor condition.
