A member of the public raised their concerns the regarding Honeypot Tearoom. The large number of customers, many of whom have little consideration for neighbouring properties often cluster on private driveways or in close proximity to living room windows and this is

It was RESOLVED that the Planning Committee write to the owners of the Honey Pot requesting that notices are put up asking customers to respect the neighbouring and leave the area to consume their drinks.

On a separate matter, as a result of Lindsay Frost's retirement, the Clerk was asked to contact him, Otford Parish Council, KALC and CPRE to try and obtains details of a recommended Planning Consultant, should one be required in the future.
