## **Grant Awarding Policy**

The Parish Council may award grants at its discretion, to organisations that can demonstrate a clear need for financial support to benefit the parish and its residents by:

- Providing a service
- Enhancing the quality of life
- Improving the environment
- Promoting the Parish of Astley in a positive way
- Improving recreation / sports

#### Who may apply?

- a) Local clubs / societies / organisations
- **b)** Regional/national charitable bodies providing a service, which may benefit the local community.

The Parish Council cannot give financial assistance to individuals under this scheme nor will it consider retrospective applications where the activity or project has already been carried out.

#### How to apply

An application for an amount of up to £100 can be made using the attached application form. The form should be submitted by a responsible member of the organisation and together with a copy of the most recent year end accounts for the organisation, sent to the Parish Clerk for consideration by the Council, between 1<sup>st</sup> November and 31<sup>st</sup> December.

Members judge applications on merit and approved grants will be paid in April.

Each application will be assessed on its own merits. The Parish Council will take into account how many people within the Parish will be positively impacted by the project and frequency of any previous awards. The Parish Council reserves the right to refuse any grant application which it considers to be inappropriate or against the objects of the council.

#### When to apply

Applications can be submitted from 1<sup>st</sup> November until 31<sup>st</sup> December and will be considered once a year at the January meeting. Only in exceptional circumstances will applications be considered outside of this timeframe.

#### **Conditions of the Grant**
