

Local Government for Langton Green, Speldhurst, Ashurst and Old Groombridge

Minutes of a Planning Committee Meeting held on Monday 16th December 2019 at 7.30pm in the Council Office, Langton Green Village Hall

MEMBERS PRESENT: Cllrs Rowe (Chairman), Ellery and Milner (ex-officio).

MEMBERS OF THE PUBLIC PRESENT: There was one member of the public present.

- 1. **To enquire if anyone present intends to film, photograph and/or record the meeting:** no one present intended to film, photograph and/or record the meeting.
- 2. **To receive and approve apologies and reasons for absence**: apologies were received from Cllr Mrs Woodliffe illness; Cllr Mrs Price prior engagement; Cllr Scarbrough work commitment; Cllr Round prior engagement and Cllr Turner prior engagement.
- 3. **Disclosures of Interests**: there were none.
- 4. **Declarations of Lobbying**: there were none.
- 5. **Minutes: RESOLVED** that the minutes of the Planning Committee meeting held on **21**st **November 2019** be approved as a correct record and signed by the Chairman.
- 6. **Matters Arising:**

The Assistant Clerk advised that she was waiting for a response from TWBC for the application for a Lawful Development Certificate for an additional parking area adjacent to the pavilion.

7. **Public Open Session:** there was one member of the public present - Mr John Jeffrey of Rushetts in Langton Green regarding Herons Oast Farm. He voiced concern regarding the dangerous turning right out of the proposed development onto the Speldhurst Road with limited visibility. The application refers to an advisory 20mph however this is during school drop off and pick up hours only. He was concerned the proposed development would set a precedent for future development spreading towards Speldhurst.

It was noted that Councillors could consider and comment on the current application only and that they were unable to speculate on future proposals.

Proposal: Erection of fence to part of boundary with Monteith Close, circa 1.9 metres high (retrospective).

Location: Brakinston, Langton Road, Langton Green, Tunbridge Wells, Kent TN3 0DH

Proposal: Variation of Condition 2 (Approved Plans) of Planning Permission 18/02929/FULL (Demolition of attached garage, single storey lean-to and shed and erection of a single storey extension on the east side and two storey extension, including a balcony, on the west side) – Increase in ridge height by 450 mm; minor revisions to fenestration including change from new UPVC windows to new timber windows to east single storey extension; alignment of ridge to west two storey extension with existing ridge (Part retrospective).

Decision: Remain neutral, leave to Planning Officer.

Proposal: Tree in a conservation area notification – T1 (Beech) – Remove low forked bough.

Proposal: Demolition of garage and carport and erection of single storey rear and extension, plus first floor

alterations and external rendering.

Location: Belsay House, 4 Holmewood Ridge, Langton Green, Tunbridge Wells, Kent TN3 0BG

Proposal: Trees: Lime Tree (T1): Remove 3 no. secondary vertical stems developed from east and south branch stubs, re-reduce crown to original pruning "knuckles" at circa 2m from main stem, consider reducing main stem to circa 6m total height.

Decision: Remain neutral, leave to Tree Officer.

Location: 18 Roopers, Speldhurst, Tunbridge Wells, Kent TN3 OQL

Proposal: Trees: Common horse chestnut (T4) – Reduce crown to a finished height of 16 metres above

ground level.

Decision: We support this application.

Location: Herons Oast Farm, Speldhurst Road, Langton Green, Tunbridge Wells, Kent TN3 0JW

Proposal: Change of use of barn to create four dwellings with associated gardens, access, parking.

Decision: Remain neutral but we have concerns with limited visibility for vehicles turning right when exiting the site. Incorrect assumptions have been made in relation to the 20mph speed limit which is only advisory and only applies during school drop off and pick up times.

Proposal: Proposed first floor rear extension.

Decision: Remain neutral, leave to Planning Officer.
