4. Secretary's report –

In May the WSBL became an associate member of Bowls England and we can now turn to them for any required advice. All the information about the benefits of this are in their booklet and we have a link on our website should you wish to explore further.

I think the Clubs are all doing their best once again to outdo each other with after match catering. It seems the competitiveness is both on and off the green.

Whatever the outcome of the AGM proposals to be voted on, I'm confident our League is in good hands and fair play, conviviality and enhanced development will always continue.

5. Treasurer's report -

This is the first year since 2019 that we have played a full competitive season with the award of prizes. It is good that we are in that position again and it is with great joy that I can tell you I will, in the spring, be chasing your clubs for entrance fees for the 2023 season.

Also (and I am not running for National Office) I can tell you that we will not be raising taxes (or in our case fees) which will stay at £30 for each team entered.

I present below the Accounts for 2022. The only income being the prepaid subs For Burnham-on-sea for the 2023 season. We have the normal web site costs which this year were £14.39 and for the first time an expenditure of £30 to become an Associate member of Bowls England. The remaining £600 being the prizes awarded for the season just completed.

This leaves us with a healthy balance carried forward to 2023 of £1201.42.

9.2 Roland Bath will be offered the position of Non-Executive Honorary Vice-President


9.3 Both divisions in the League can be increased to a maximum of fourteen (14) teams.
