Location: 21 Newlands, Langton Green, Royal Tunbridge Wells, Kent

Proposal: Demolition of two existing houses and the erection of six 3-bedroom homes and four 4-

bedroom homes, plus associated access, parking and landscaping.

# 17/04294/FULL

Location: Land Adjacent Keepers Cottage, Burnt House Lane, Speldhurst

Proposal: Construction of 4m wide by 25m long loading bay with a 10m bell mouth entrance to Shadwell and Sprouds Wood, including replacing hedgerow, replacement gate and erection of

fencing.

Proposal: Replacement front porch; internal reconfiguration and alterations to fenestration; two

new high-level windows to first floor side elevation. Decision: Remain neutral – leave to Planning Officer.

Location: Building to the Rear of The Black and White Shop, The Green, Groombridge, Tunbridge

Wells, Kent TN3 9QH

Proposal: Removal of Condition 4 (Use Class) of Planning Permission 10/02640/FULL.

Decision: We object. We are concerned about the impact on the amenity of neighbours and locality

and concern that this could ultimately lead to conversion to residential.

Proposal: Alterations to existing house including new entrance porch, single storey link to garage, removal of west chimney with new two-storey side extension and drive (Part Retrospective).

Decision: Remain neutral – leave to Planning Officer.

## 19/02816/TCA

Location: The Garden Cottage, Speldhurst Road, Langton Green, Tunbridge Wells, Kent TN3 0JL

Proposal: Trees in a Conservation Area Notification Ilex (T1) – Fell; Acacia (T2) – Reduce by 20%;

Acer (T3, T4) - Reduce by 20%.

Decision: We object to the felling of the Ilex (T1) with no justification given.

#### 19/02850/FULL

Location: 70 Dornden Drive, Langton Green, Royal Tunbridge Wells, Kent TN3 0AF

Proposal: Erection of two-storey side extension and front porch extension.

Decision: Remain neutral – leave to Planning Officer.

# 19/01951/LBC

Location: The Forge, The Green, Langton Green, Royal Tunbridge Wells, Kent TN3 0JB. Proposition: Listed Building Consent – Removal of deteriorating asbestos guttering and two

downpipes; replacement with black UPVC.

Decision: Remain neutral – leave to Conservation Officer.

## 11. Compliance Issues:

- a) Application no. 18/02929/FULL Brakinston, Langton Road, Langton Green a NMAMD application had been submitted. Councillors were disappointed that they would be unable to comment and asked the Assistant Clerk to email TWBC contesting the non-material application. The proposal is half a metre higher on the roof of an extension which Councillors strongly objected to.
- b) The Old Dairy, Barden Road, Speldhurst Cllr Mrs Price queried whether the new hedge had been planted stating that is was now planting season. To be monitored.
- c) The replacement of a hedge with a fence bordering the Langton Road into Tunbridge Wells, just past the turning for Dornden Drive, was noted. To be monitored.
- d) Cedar House, Monteith Close Fence removal. To be monitored.
