EPC view: This proposal will fulfil Egerton Parish Council's ambition on behalf of the village to develop the site - former Orchard Nurseries - with homes that are suitable for older people, designed with good accessibility and spatial capacity for those with mobility or other difficulties as can be seen from the floor plans and in the design and access statement. Egerton Parish Council (EPC) has been collaborating closely with the developer on this project to ensure there is flexibility in



the interior design to include scope for such facilities as lifts for upstairs rooms or wet rooms where cloakrooms are shown. The layout of the site and outline elevations of the homes complement the village setting and the best of old and new property designs in the village, in line with the Parish Design Statement.

It has taken time for the access to this site to come to fruition and EPC is delighted to have identified a developer who can deliver the project in a holistic and attractive way to complement and respect the village setting whilst meeting community ambitions.

The Egerton Neighbourhood Plan, adopted by Ashford Borough Council in March this year (2022) includes this site in Policy D5 for such development, to meet the needs of older owner-occupiers in the village wishing to downsize and live in more suitable homes. This need was confirmed by a professional Housing Needs Survey conducted by the Association with Communities in Rural Kent (ACRK) on behalf of the Neighbourhood Plan Steering Group. The site itself was gifted to EPC by the late Derek Marks for the benefit of the village, without stipulations, and the profit derived from the land on sale of the houses at open market rates will go towards building the pre-school (which already has planning permission on the school site) and to other village projects such as an extension or improvements to the Millennium Village Hall. Villagers, who voted overwhelmingly in favour of the Neighbourhood Plan (92% of the vote) will stand to gain in multiple ways from this development. The site which was once a horticultural site with associated paraphernalia has been derelict and overgrown. Since its associated bungalow and garden was sold and redeveloped privately there has been no pedestrian or vehicle access to the site. Now that the developer has achieved means of access to New Road, the full potential of the site can be realised, and the needs of the village well met. Without this, the site would become land-locked and of no value: indeed, it would be a liability and be no asset to the village, becoming more derelict and impossible to manage or use. The developer has reassured EPC that the trees and hedges on the edges of the site will be preserved and enhanced to maintain a buffer zone on the edge of the open countryside and remain an ecological feature. This would need to be reflected in any conditions that may be attached to planning permission.

Echoing Ashford Borough Council's housing policies, this development gives older owner-occupier residents more choice in independent living, in parallel with the Government's new Social Housing Charter to give tenants a better deal. It mirrors ABC's approach to independent living in the 21st century. EPC has already taken steps to publicise the proposals for this development and in co-operation with the developer, will go further with its publicity to seek interest from older villagers who may wish to purchase a home on the site, and with their permission pass their details to the developer so that they may have priority in buying one. The catalyst for change in ABC has been Britain's ageing population, which has driven a national focus on housing provision for this sector. In Ashford, where in just two years' time it is expected that nearly a quarter of all residents will be aged 65 or over, this proposal will help meet ABC's objectives too.

EPC wholeheartedly supports this application as being a substantial asset to villagers beyond just older residents as buyers of the new homes. The homes in this proposal near the centre of the village will meet the needs of older people in the village wishing to sell their existing large and unsuitable houses and be closer to village facilities and part of a sociable and supportive community; it will release their houses for sale to others within the village who need to upsize and stay in the village or to others who wish to move into the village and help sustain it. This development will lead to the availability of funds to build the pre-school, improve the village hall and other projects, thus contributing significantly to the sustainability of the village. The plans complement the principles in the Parish Design Statement and will enhance what is now wasteland, almost being a brownfield site.

b) **MBC plan review – Lenham Heath Garden Development**

Cllr Lois Tilden reported that MBC had been very slow in submitting additional documentation as required by the Planning Inspector and as such, the Inspector agreed to defer the hearing for two months; it will start again in November. Cllr Lois Tilden would study new material as it arrived to determine the need for additional representations at the Hearing. She and Cllr John Lawton will update EPC at its next meeting.

10) Affordable housing - update

The full application for the development of Gale Field has been submitted to ABC but as yet not registered.

11) Older People's Accommodation - update

Chairman Richard King proposed that EPC Working Group for Older People's Accommodation (WGOPA) should meet EPC's solicitor to review draft Heads of Terms with Lansdown Asset Management and approval of an indicative spend of £2,500 - £3,000 to cover necessary legal fees. He said the amount seemed reasonable in the context of the potential profit from the sale of the land which would be ploughed back into the village to build a new pre-school and, funds allowing, support other improvement works to the Millennium Hall.

The Clerk read a letter received from Lansdown Asset Management on 16th September 2022, the developer. **See Appendix III**

It was agreed, following the reading of the letter, EPC WGOPA would draft a letter that, if outline permission was granted, would be circulated to every house in Egerton in the February edition of Egerton Update, asking older people interested in a property at Orchard Nurseries to put their name(s) forward. EPC would share respondents' details with the developer on a confidential basis.

12) Review and approval of the EPC Risk Assessment 2022

The Risk Assessment policy was circulated to all Cllrs ahead of the meeting. It was agreed that any monies rolled forwards from a prior financial year would not be used to offset the full amount of the annual precept.

13) User needs survey on Egerton public transport – buses

It was agreed EPC would join with Pluckley and Smarden Parish Councils and circulate a survey of residents' user needs re bus services. The survey will be offered for completion on-line via the EPC website and in print in the next edition of Egerton Update. Completed research will be collated and



given to Cllr Guy Washer of Pluckley Parish Council to produce a report. Timings and EPC share of costs pending.

16) Additional items

- Playing fields

EPC Egerton Playing Fields Committee members Cllrs Jeff Hopkins and Tim Oliver said that trees were overhanging the cricket field and old core wood needed to be removed from behind the basketball area as it was being rolled down the hill.

Action: Clerk, Cllr Hopkins and Tree Warden Graham Howland to do a site visit to note the trees/wood and advise EPC of any works needed and costs.

Cllr Jeff Hopkins also advised that repair work was needed to fill the ground cracks in the football field and cricket pitch after the dry summer. The costs of the works will be met by the Geoff Wickens Trust and expected to cost in the region of £7,000.

- Replacement of wooden fencing around skatepark

The Clerk advised fencing around the skatepark had been broken. It has now been removed as a cost-effective and safe solution. Fencing is not a legal requirement around a skatepark or play area.

- Egerton Christmas Fair – proposal to set up an Egerton Parish Council Working Group to organise the Egerton Christmas Fair

It was proposed that EPC set up a working group to explore the running of a Christmas Fair in December 2022 at the village hall. Cllr Richard Wall will sit on the Committee.

- Approval of proposed format for staff appraisals

The proposed format was circulated to all Cllrs in advance of the meeting. It was agreed to adopt the policy subject to one minor amendment. **All in agreement.**

- **Crockenhill Road Telecomms Monopole**

Vice-Chairman Peter Rawlinson said he had received a reply from MP Damian Green to his letter that queried the long delay to the building of the monopole given planning permission in Crockenhill Road near the junction with Forstal Road in 2019. The letter reported that Virgin/O2 expected the monopole would be in situ by Christmas.

- **Egerton Book of Condolence**

Cllr Claire Foinette said that the Book of Condolence marking the passing of Queen Elizabeth III remained at St James Church. Chairman Richard King proposed that it should remain in the village archive and not be transported to ABC for central archiving. **Proposed:** Chairman Richard King.

Seconded Cllr Pat Parr. **All in agreement.**

- **Ash tree at Pembles Cross**

EPC tree warden Graham Howland reported that the large ash growing on the island at Pembles Cross is suffering from ash die back and needs to be felled. It was agreed that in due course another tree should be planted there as it was a significant loss on a designated Green Space in the Neighbourhood Plan.

Action: Cllr John Lawton to report to KCC highways for action.

The confidential minutes of the close session 6th September were read by the Clerk. The minutes were approved as a true record of the closed session.

Dear Sonia

I am pleased to confirm that we have been advised by Ashford Borough Council that the planning application submitted last July has at last been registered and whilst this is an outline application there are some procedures that we need to follow and some information that we will require in due course.

Earlier this year, I believe it was in May/ June, I attended and open evening at the Village Hall to present out proposed plans to the public. At that time, I did raise with the Parish Council that we would need a list of the names of people who would be interested in purchasing one the new properties providing, of course, planning consent had been granted.

I am aware that no list of prospective occupants currently exists and of course this would make sense in the absence of a detailed planning permission. May I however request that Egerton Parish Council canvasses interest in the scheme with a view to compiling a list of qualifying people who would like to buy one of the properties at market value.

This will ensure that older people living in Egerton and the immediate area are given first opportunity to purchase one of the units off plan; we will of course keep this information confidential.

We merely wish to honour our commitment to ensure that the names of anyone on the list to be prepared and presented to us meets the qualifying criteria, in so much that these properties have been designed for older people's needs.

It would be our intention to only offer these dwellings for sale to the Egerton older persons community and this will be for a period of 6 months prior to any of the dwellings being offered in the open market.

The appropriate time to canvass interest would be once the outline planning consent had been granted, so there is no action required at this stage,
