Ward Overview

Pars Development, Townsend Road, Shrivenham

Kat has submitted a response to a new application for a private wastewater treatment works at this ten home development. We strongly object to the private solution which will discharge 5.7m³ treated waste per day into the field next door, and make residents responsible for the management of foul waste. We are expecting the application to come to planning committee shortly.

Food Businesses and Litter

In response to a new Vale initiative to reduce the amount of litter being dropped from takeaway businesses, Katherine has asked for Watchfield McDonald's to be considered for the scheme. The Cabinet member responsible has agreed to speak to officers about this:

Viral has continued following up with the County Council Highways engagement team and has been informed that budgeting is complete, and we are now waiting for the contractors to provide a works schedule. The expectation is on completion the culvert blockage/collapse will be investigated and repaired and works carried out on the footpath that has been disrupted.

Fernham Dropped Kerb

Following Kat's direct request to OCC officers at the FATAAC meeting, we are pleased to learn that the dropped kerb in Elmside, Fernham has now been installed, giving residents safer access to the car park. Thanks to the officers who have followed this up quickly after Kat first raised this issue in 2021.

Little Coxwell Playing field

Viral has continued to keep in touch with Council officers on the process of this land disposal to the parish council. Officers at the Vale are periodically reaching out to the Ministry of Housing, Communities and Local Government to get some priority on this.

Future Oxfordshire Partnership

The Future Oxfordshire Partnership was originally set up as the Oxfordshire Growth Board, bringing together all of Oxfordshire's councils and organisations including the NHS, Oxford Universities and the Environment Agency. As Chair of Joint Scrutiny, Kat has been responding to new proposals for a "slimmed down" FOP, which will become a Board of the council leaders to discuss cross-county issues. Government proposals for devolution are likely to be at the top of the agenda. Our main concerns are around a lack of attention to scrutiny of the new body, vague proposals regarding its remit, and a lack of detail about the funding the new Board requires. Vale budget setting process is ongoing

The Vale of White Horse is in the process of setting next years budget, as a Green group we are looking to propose some extensions to schemes being considered to put the council in a stronger position to reduce their long-term outgoings.

Consultations

Bathing water quality regulation consultation

The government department (DEFRA) is consulting on bathing water quality regulations, specifically:

- removal of automatic de-designation after 5 years of 'poor' water quality
- changes to the designation criteria of bathing sites
- removing the fixed dates of the bathing season from regulations

Enabling remote attendance and proxy voting at local authority meetings

The government is consulting on allowing remote attendance and proxy voting for local authorities. Local authority meetings and committees are required to meet and vote in person, and this is a major barrier for many people, especially those with mobility issues or with young families, it is right that we should consider how we can adapt these processes to encourage participation in our democratic processes from a wider spectrum of our society.
