Minutes for the meeting of Doddington Parish Council on 12 October 2015

1 APOLOGIES

Mrs Jackson also reported that she had been a victim to a Dropbox scam.

Cllr Haynes informed Councillors that Community Warden Dave Osborne has reported he has been to Doddington three times in the last month and has not come across any issues apart from cars parking on the kerb opposite the Village Hall. He has have not received any phone calls from residents of Doddington about any problems.

Cllr Haynes said that pavement parking causes a problem for people with prams and pushchairs.

Cllr Duckworth informed members that Cllr Fraser had cut back the brambles at the top of the Playing Field and the area will be reviewed in the Spring. The bench at the far end of the Playing Field needs to be sanded down and treated. After the last cut by the gang mower, Cllr Duckworth brushed the loose cuttings off the tarmac and noticed the area was going green again and this will be monitored.

Cllr Duckworth reported that he spoke to the tractor driver after the last visit and this was the last scheduled cut, there may need to be a further cut.
