155/1819 PUBLIC PARTICIPATION SESSION

A member of the public asked if the council could go back and check that planning permissions is being complied with. The hedge on Valeswood Lane by entrance to The Cliffe should not have been removed as it is not a permitted entrance, obstructing the Right of Way. In regard to the visibility splay a laurel hedge has been planted outside of the hedge line and will be in front of the boundary – this was meant to be a holly/hawthorn hedge on the plans.

It was reported that pot holes are getting on worse.

The two candidates for the Great Ness seat introduced themselves then left the room while the vote took place.

Cabinet re-shuffle – aiming to push forward digital transformation programme. Cllr. Potter now Portfolio Holder for Education and Children's Services with Cllr. Bardsley as deputy. Highways re-structure now done but a few posts still to be filled between now and June. Some concerns re Kier and their financial situation nationally.
- c) Youth Club Youth Club still going strong and regularly getting new members. A Baschurch parish councillor visited and was happy with how the club is run and Baschurch PC will be making a donation shortly. The clerk was asked to check if the club is insured under the main council insurance

They are looking to replace flooring as it moves when it gets damp and may apply to the parish council for part of the cost; there is a wide range of costs depending on how the issue is to be addressed.
