# **East Drayton Parish Council**

Minutes of the Meeting of the Parish Council held at 7.30pm on Tuesday, 17<sup>th</sup> July 2007 in the Village Hall

#### Present:

Cllr D Allen (Chairman), Cllrs J Parker, H Shreeve, J Goddard, R Small and P Ogle, PC Bailey and PCSO Ciacci. In attendance: S Pickard (Clerk). Members of the public: 2.

1 Apologies for Absence - Apologies were received from Cllr M Ogle and CCllr J Hempsall.

## 2 Minutes of meeting held on 19th June 2007

The minutes of the above meeting were approved and signed as a true record. In addition, the minutes from the Extraordinary Parish Council Meeting held on Thursday, 28<sup>th</sup> June 2007 were approved and signed as a true record (as attached).

3 The Chairman welcomed PC Bailey and PCSO Ciacci to the meeting and they gave a report:

PC Bailey said there had been three crimes during the last ten days; a repeated break-in at The Paddocks on Long Lane and damage to fencing and a gate leading to a remote aerial mast (most possibly to the siren). Cllr Goddard said the cricket field locks had been broken, but PC Bailey was unaware of this and he stressed the importance of reporting incidents so they could be recorded. PC Bailey added that thefts of scrap metal and diesel fuel continue to take place in the surrounding area.

## 4 Matters Arising

# a) Environmental health issue at Vine Farm

The Chairman asked for an update on the situation and Cllr Philip Ogle said that they had pumped out 4" of clean water from the cellar again last night. The Chairman said the wider issue would be discussed under Agenda item 7ii.

# b) Nottinghamshire County Council request re Back Lane

The Clerk advised there still had been no response to date concerning the requests to Nottinghamshire County Council to repair the surface of Back Lane. The Clerk had contacted CCIIr Hempsall who said he had spoken to Laura Summers at Notts County Council who has agreed to respond in writing; she is on holiday until the beginning of August.

#### c) Manor Farm Business Park

The Chairman referred to the extraordinary meeting held on 28<sup>th</sup> June to discuss the above planning proposal and the Clerk read out the comments sent to Bassetlaw District Council. The Parish Council has no objection to the Renewable Energy Centre, but strongly objects to the manager's house. (Minutes attached).

#### 8 General Business

- i) <u>The Code of Conduct.</u> Parish Councillors have had the opportunity to read through the new Code of Conduct in full and after discussion a decision was reached. It was PROPOSED by Cllr Goddard that the new Code of Conduct be adopted unamended and SECONDED by Cllr Small. All AGREED.
- ii) <u>Flooding in the village.</u> It was AGREED there is a need to pursue the mapping of the old drains in the village and Severn Trent and Bassetlaw District Council should be contacted again advising that unless there is better co-operation the Parish Council will further liaise with the Consumer Council for Water to ensure they fulfil their statutory obligations. **ACTION: S Pickard.**

# 9 Meeting adjourned for Public Discussion

i) Further discussion followed regarding the recent flooding problems throughout the village. The frequency of clearing of ditches and cutting of hedges is now determined by Defra, who are more concerned with conservation for wildlife. The Chairman said the matter is not as straightforward as people might think as regulations for such clearing and cutting are kept to a minimum for conservation purposes and added that the Council would continue to discuss the matter with Severn Trent.
