## **Mabe 20mph Speed Limit and Traffic Calming**

Cormac Solutions Ltd on behalf of Cornwall Council is inviting comments on proposals to regulate traffic speeds and volumes through the village of Mabe by providing traffic calming features together with a blanket 20mph speed limit throughout.

These proposals have arisen as a result of concerns raised by Mabe Parish Council regarding the speed and volume of traffic passing through the village, particularly those motorists who use it as a shortcut to travel between the A394 in the west and the A39 in the east.

The proposals include the provision of two buildouts, one on Antron Hill and one on Church Road, along with a series of speed cushions throughout the village designed to support the introduction of a reduced speed limit of 20mph, to be applied to all roads leading into the centre of the village. The 30mph speed limit at the western end of Antron Hill will be extended to support the 20mph zone. In addition, a section of no waiting at any time restrictions are being proposed at the Antron Way/Church Road junction to help improve the traffic flow in this area which often suffers from congestion as traffic backs up blocking the junction area.
