## **379** South Worcestershire Development Plan

The Chairman stated 18 residents had put their thoughts and considerations into the Parish Councils request for their opinion regarding the MHDC SWDP. He stated the Parish Council would take the

parishioners views into consideration when making any future comments on the SWDP. Councillor Mosedale arrived at 7.36pm.

#### 380 Community Links

In the absence of Councillor Jill Griffin, the Chairman stated Councillor Griffin had organised a Litter Pick together with Malvern Hills District Council who will be providing all the necessary equipment. We already have volunteers to join in with the pick which will take part on Saturday 9<sup>th</sup> November 2019 meeting at the New Inn at 10-30am.

A native Daffodil Bulb Planting Event to brighten up the roadside through the Village in the Spring would take place on 7<sup>th</sup> October 2019 meeting at the Village Hall at 10.30am. The PC hope many residents will be able to volunteer to help.

A date for a Walk in the Woods for 2020 was awaiting a confirmation date off Mr Richard Bowles.

#### 381 Village Maintenance

Councillor Dymond confirmed a second litter bin had been installed opposite the Village Hall in the Bus Layby. A new bin opposite the New Inn leading into the woods was awaiting fitment.
