171/2025 Chairman's Welcome

Chair welcomed everyone to the meeting.

Many thanks to Cllr. Sale who represented Church and the PC at CE Remembrance Day Service on Sunday 9th November. The service went well and was well attended.

Many thanks to the planning Sub-Committee who have met twice since the last meeting regarding the planning issues currently concerning the parish.

176/2025 To receive updates from parish community organisations – CECA, Church, Club

CECA provided update on their current position including financial overview and upcoming vacant position (Treasurer). Events continue to decline due to lack of support, thereby affecting CECA income which raises concern regarding mid to long term financial position of CECA. Chair to attend next CECA meeting to discuss further. Any parishioner wishing to join CECA will be more than welcome and can contact CECA directly. Agenda item to remain to capture further updates.

Church updated that no funding received from the diocese following the sale of the old schoolhouse site. Thanks to PC for continued funding for Churchyard mowing. Vestry roof in process of being repaired.

No update from CE Club.

177/2025 Safety in the Parish

Concern that, if passed, 25/03820/VAR Construction Traffic Routing Scheme (Solar Farm) will seriously affect safety in the parish particularly along Eaton Road past the Jubilee Hall and Playing Field despite PC continuing to work to improve safety. This is a major concern as the PC have been working to improve all aspects of safety in in the Parish.

Hedge at Mill Green crossroads continues to be overgrown and impede vision despite being reported.

Action: Chair to raise with SC again.

178/2025 Highways and footpaths

a. St Michaels/Crow Lane 7.5 tonne weight restriction – on-going management, reporting, enforcement and further options.

Enforcement of weight restriction violations have not been taken up by SC despite parishioners continued efforts to achieve this.

b. Eaton Road (village part) safety improvements.

Chair has proposed two further locations to SC for speed assessment on existing highway furniture (posts) opposite the old post office on the Newport Road, and on the junction of Narrow Lane and St Michaels Way. Need and positioning of SID/VAS to be agreed once results are known. No update from SC or Highways.

c. A41 working group – updates on new cross county group.

The engineering report for the A41 has now been produced by Amey. The report concluded that speed cameras would not produce the desired outcome and instead have suggested making considerable changes to 4 locations along the A41. No decisions have yet been made on these locations or next steps for the project.

- d. Footpaths and public rights of way to consider any queries which may impact on the parish. No update.
- e. **Streetlights Lamp replacements. Dark skies initiative.**No issues.

b. Shropshire Council - review of Memorandum of Understanding

Chair has circulated the MOU to councillors for consideration. SC have asked Town and Parish Councils to sign a MOU (Memorandum of Understanding) regarding working closely together in respect of transferring responsibilities, however, limited detail included. Funding and workforce (volunteers) for transferred liabilities was discussed.

RESOLVED: PC to acknowledge receipt of the MOU but decline to sign MOU until further details are received.

c. Best Kept Village 2025

CEPC have won the North Shropshire 2025 Award, with a £500 prize. The prize money has now been claimed and will be forwarded to the PC in due course. Certificate and Plaque are displayed in the Jubilee Hall and Club respectively.

Winter planting has begun in the troughs at the entrance to the Village and near the playground. A decision as to what form the "village action group" will take next year and whether to apply for next year's competition will be taken in Spring 2026.
