19/2019 Introduction to Cllr Steve Davenport Portfolio Holder for Highways/Transport Shropshire Council. Cllr Davenport did not attend the meeting. Action: Clerk to contact and make arrangements for the future.

20/2019 Roads & Rights of Way

<u>Community Led Concern</u>: Submitted to Shropshire Council February 2018 (see below) put on hold for 2 years.

- o HGV's from C J Wildbird Foods and using Withington as a short cut to Upton Magna.
- o Agricultural Contractors Vehicles using Withington as a "rat run" to Upton Magna Farms.
- <u>Excessive number of field accesses onto the highway from Sandy Lane to Upton Magna causing</u> mud to be spread along the road.

In order to solve the problems with the HGV's visiting CJ's a proposal has been put forward to Upton Magna PC asking their opinion on making the junction on Sandy Lane wider on one side thus allowing HGV's to turn right to CJ's instead of them travelling into Withington. Upton Magna PC are not in favour of this proposal as they think that the HGV's will end up in Upton Magna. Jason Jordan reported that the Sundorne Estate is willing to donate the land and work with Shropshire Council to resolve the problem.

21/2019 Action Updates from Previous Meetings

- Removal of field hedges in Barkers Square: Planners are looking into this.
- Damage to road verges on the Walcot Lees to Rodington Heath road. Nothing to report

Cllr Picton said how much she had enjoyed the Summer fete. The new highways repair reporting system is being revised to ensure the correct action taken is recorded against each repair.

Cllr Timmis reported that he had investigated the use and supply of "Smart Water" after seeing an article in the parish magazine. There is a scheme supplying kits via Parish Councils at a reduced price of approx. £10.95 per kit. The kits are usually £25 + Vat. Further funding may be awarded by the Police Crime Commissioner bringing the price down to £8.90 per kit. If more than 80% of residents in a village have used smart water signs saying "we don't buy crime" are supplied to be displayed in the area. Action: Cllr Timmis and Clerk: a letter will be sent out to all parishioners in order to gauge the level of interest.

Joe Ford brought up the problems some families are having getting their children enrolled at their chosen Secondary School: Action: Joe to contact Clerk with details/

Cllr Stone mentioned that the Whitehall Medical Practice is set to be closed in September. This means that there will be only one practice in Shrewsbury that includes Withington in its catchment area that practice being Severn Fields.
