BERRINGTON PARISH COUNCILThursday 2nd July 2015**MINUTES**

1) Welcome by Chairman: The Chairman welcomed all to the meeting

2) Present and Apologies: Councillor C Wild-Chairman Councillor R Purslow-Vice-Chairman Councillor L Picton Councillor R Ward Councillor C Bonsey

Members were concerned at the risk of an accident. A member's Great grandfather used to maintain the pump for the estate. Also request that Shropshire Council look into the ownership of this small piece of land.

The clerk to contact the Environment Agency to bring the state of the well to their attention.
