#### 4 Report from Dorset Police – Safer Neighbourhood Team

PC Dave Mullins delivered a report, the highlights of which were:-

- The year has seen a drop in crime in Dorset of 15%
- There were 102 crimes reported in the Blandford South area during the year
- Figures for Milborne are consistent with previous years
- There has been a small increase in burglaries from rural dwellings
- SNT team numbers are falling as a consequence of tight budgets
- A change in priorities is 1) Victim, 2) Offender Management and 3) Community liaison
- Contact PCSO Luke Goddard for suggestions for new Neighbourhood Watch Coordinator.

The report was followed by a question and answer session during which it was the general feeling that the Home Ring Around system should be reintroduced in the village. To be followed up by new Neighbourhood Watch Co-ordinator.
