

# East Drayton Parish Council

Minutes of a Meeting of the Parish Council held  
at 7.30pm on Tuesday, 20<sup>th</sup> September 2011 in the Village Hall

## 3 Matters Arising

a) Village Signs - The Chairman confirmed he, Cllr Ann Stanley and Mr Steve Ellis had visited Malcolm Lane & Son Ltd, sign makers and even at this early stage, they looked impressive. Mr Ellis had taken some photographs and these were circulated at the meeting. The signs will be ready in six to eight weeks when a site survey will be carried out and final positioning agreed with Mrs Jan Pauley at Notts County Council. The new signs are wider than at present and will be sited outside the 30 mph limit (to be fitted with sheer legs designed to snap should a vehicle collide with them). New lollipop-type 30 mph signs will be erected.

b) Queen's Diamond Jubilee – The Chairman confirmed Cllr Small had kindly agreed to offer a barn for a ceilidh (Pinch O' Snuff booked) and The Blue Bell Inn will provide bar facilities. Consideration being given to a memento for the children; most popular suggestion was for individually-named chocolate medallions from The Chocolate Factory in Retford.
