FOUR HUNDRED AND THIRTEENTH MEETING OF THE CHAR VALLEY PARISH COUNCIL ON MONDAY 9TH OCTOBER 2017 AT WOOTTON FITZPAINE VILLAGE HALL

3944: Declarations of interest: Nothing was raised

3945: Resolution to approve the minutes of the Parish Council meeting held 11th September 2017: Draft minutes had been circulated and were approved and signed by Cllr Snook

3946: Actions following last meeting: — Enforcement issues — following Cllr Turner's comment that Kevin Perry is on long term sick leave, the clerk received a telephone call from Cllr Christopher that Debra Redding a higher-grade planning officer at WDDC is taking on the enforcement duties in his absence. The clerk has written to the owners of Brigs Farm and Little Oak Farm regarding hedge cutting.

The planning application for Stubbs Cottage in Bluntshay Lane is going before the planning committee on 12 October.

The clerk attended two training sessions since the last meeting – for new and nearly new clerks and the clerk's seminar, she will be attending a course on budgets and precepts on 12 October.

The village hall at Whitchurch has been booked for 7.30 on Monday 6th November for the finance meeting – Cllrs. Snook, Johnson, Everidge, Bailey and Creed Castle and the clerk have been asked to attend. The second instalment of the precept and the LCTS grant totalling £10,257.50 have been credited to our bank account on 27 September

3947: Reports:

Dorset Association of Town and Parish Councils: Cllr Snook is to attend the annual conference which is taking place on Saturday 4th November at DCC council chamber in Dorchester

Bridport Local Area Partnership: Cllr Everidge reported that there had been a flurry of activity surrounding homelessness. The CAB have been very good and have raised a questionnaire advising that three projects are being set up – one in Weymouth relating to street intervention, Pilsden – the only project offering overnight accommodation and Bridport – involving one family where the children are living with their grandparents whilst the parents are living in a tent. At present the Fisherman's Arms are out of the equation for conversion to Bridport Connect as Palmers Brewery want £2,000,000 and it appears that there is a main sewer under the site. Another option is to retain the land from the old Sydney Gale site near Flood Lane. There is a possibility of building houses for the keyworkers on the land at Beres Farm. Penwithen near Dorchester should remain as it is for children with special education needs.

Transport: Cllr Everidge: following the WATAG meeting on 28th September an amended timetable is evolving and they are looking at the transport situation from 8th October – there will be no X51 bus to Dorchester on Sundays. Regarding the bus route to Marshwood Primary, the principal will contact Cllr Turner. Cllr Everidge attended a civil society meeting that lasted for 6 hours, they will be meeting again on 20th October with Oliver Letwin to discuss the A35.

Trees and hedges: Clir Peck reported that she noticed that more people seem to be cutting down trees as they are in the way rather than being diseased

Lengthsman: Cllr Creed-Castle had been unable to contact the lengthsman regarding the tree at Whitchurch playground that requires attention, there are a lot of stones on the road near Brigs Farm that need moving and the drain near Champerhaynes Lodge needs clearing. The area around the grit bin near Ship Knapp also needs clearing.

3948: Councillor Reports:

Cllr Snook: will speak to Alex Brooks as the next fingerpost that requires attention is at Baker's Cross

ClIr Everidge: had received an E mail from Highways with an attachment of a poster that she was unable to print on A4 paper – can DCC make sure that anything they send can be printed on A4 paper. There will be a Homewatch meeting in Morcombelake on Thursday, ClIr Everidge will raise any questions that are put forward. ClIr Everidge will draft a letter to WDDC regarding dark skies.

CHAR VALLEY PARISH COUNCIL

Cllr Creed-Castle: wished to thank Cllr Turner for his assistance in the problems at Pilsden View Camp site

CIIr Mahaddie: had received a phone call from Penny Watt saying that the owner of the new tea-shop on the A35 had seen a huge vehicle in the field opposite entering and leaving the field belonging to the owner of Copplestones who has a very large mobile home in the garden. The clerk will check the original planning application for Copplestones.

Clir Johnson: on the road between the Five Bells public house and Ryall the hedges are getting wider and wider and whilst they are tidy they considerably overhang the road. Clirs Sage and Snook will take a look and report back to the council.

ClIr Peck: mentioned the amount of time it takes to contact planning at WDDC and then to speak to someone who can help. The clerk will contact BLAP to see how this can be improved. ClIr Peck also advised the meeting that Western Power are burying electricity cables through the village of Loders and she wondered whether the same could be done in our parish, she will contact Western Power for further information. Following on from our last meeting when Tara Hansford gave a talk, ClIr Peck asked that we contact her team to ask whether they can maintain the footpath between Dolphin Caravan Park where it meets the road at Charmouth as it is very overgrown and there is a leaking cattle water trough. The clerk will contact Tara Hansford department to see what can be done.

3949: County Councillors Report: Clir D Turner advised that the local government review on the unitary policy is expected this month – should have been today. Two new bus services have been created – one between Beaminster and Bridport Hospital and another between Bridport and Yeovil College going via Broadwindsor – this service is trial run for 3 months and starts at 7.30am.

District Councillors Report: Cllr S Christopher advised the meeting that Stubbs Cottage is going before the planning committee on Thursday 12th October and asked whether of the councillors would be attending. There is concern about the lack of buses in West Dorset especially in Bridport.
