59/25 Apologies:

Due to illness Mrs B Carter has been unable to take up the position as a Town Councillor. The Council will re-advertise the vacancy which can be filled by co-option. Apologies were received from Cllr J Rickson, Cllr S Demos, Cllr D Mills and Councillor D Evans.

60/25 Members of the Public:

Sergeant Jenny Price attended the meeting who is responsible for the Craven Arms Area gave an updated on local policing issues, the Town Council confirmed that the main issues related to Anti-Social Behaviour, Speeding and Drug Issues.

Shropshire Councillor J Dickin had provided the Council with a detailed written report which had been circulated to members but highlighted continued Highway Issues, Temperance Hall Site, Connexus Housing Site in Station Road Craven Arms, Craven Arms Flooding Issues, Partnership Working with Parish and Town Councils and the Shropshire Council Financial Position.

A member of the Public attended the meeting to raise issues of speeding along Watling Street Craven Arms. A member of the Public attended the meeting concerning fund raising for Halford Church.

61/25 Declarations of Interest:

There were no declarations of interest.

62/25 Minutes: - The Town Council confirmed the minutes of the meeting held on 29th July 2025 and they were duly signed by the Vice- Chairman.

63/25 Matters arising from the Minutes:

64/25 Chairman's Items:

The Chairman was unable to attend the meeting but had produced a report which had been circulated to all Town Councillors prior to the meeting this referred to the Shropshire Council financial difficulties and future partnership working between Shropshire Council and Parish and Town Council.

The Clerk reported that the sale of the Council Land adjacent Barclays Bank Corvedale Road Corvedale Road Craven Arms **to** Bramley Property Holding Limited who had obtained planning permission for the development of two houses on the site will be completed within the next few days and that the proceeds of the sale price less solicitor costs will be transferred to the Councils bank account.

65/25 Amenity Items:

- a) Craven Arms Playing Fields It was pleasing to note that the field was being used by a local football team for the forthcoming season
- b) **Craven Arms Flooding Scheme-** Cllr R Pitt is collating information received from residents concerning a clearance of the watercourses however was disappointed at the response for volunteers. Cllr R Pitt had also held a meeting with Shropshire Council representatives to discuss the flooding issues. The Grill at Stokesay had been altered to allow a better waterflow of the stream.
